

SUBORDINATION AGREEMENT

This Subordination Agreement, made and entered into on this the Abb day of AUGUST, 2012, by and between BRYANT BANK, ITS SUCCESSORS AND/OR ASSIGNS, as Party of the First Part, and BANCORPSOUTH BANK, ITS SUCCESSORS AND/OR ASSIGNS, as Party of the Second Part.

WITNESSETH

THAT, WHEREAS, RUSSELL BRYAN SHANAHAN AND BARBARA M.
