

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Three Hundred Sixty Nine Thousand Nine Hundred Seventy Five No/100 Dollars (\$369,975.00) paid by the grantee herein, the receipt of which is hereby acknowledged, We, Kevin L. Horton and Debbie C. Horton, husband and wife, (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto John Benjamin Black and Josi Black, (hereinafter Grantee), as joint tenants with rights of survivorship, all of our right, title and interest in the following described real estate, situated in Shelby County, Alabama.
