## CONSENT JUDGMENT BETWEEN THE SHERWIN-WILLIAMS COMPANY, QUALITY PROPERTIES, LLC AND FIRST NATIONAL BANK OF TALLADEGA

At the request of the undersigned parties it is hereby ORDERED, ADJUDGED, and DECREED as follows:

1. Consistent with this Court's Opinion and Order on Motion for Summary Judgment by the Sherwin-Williams Company (hereinafter "Sherwin") and Motion for Summary Judgment by First National Bank of Talladega entered on May 14, 20!2 (hereinafter "Order"), Sherwin holds a perfected and enforceable materialman's lien against the Project (the term "Project" in this Consent Judgment has the same meaning as in the Order and the property is specifically described below to wit:

Lot 1, according to the Survey of 31 Plaza, a Commercial Subdivision, as recorded in Map Book 39, Page 150, in the Probate Office of Shelby County, Alabama)

and Sherwin is entitled to an allowed secured claim in the Chapter 11 case of Quality Properties,

L.L.C. (Case No. 10-42783-JJR).

2. Sherwin is hereby awarded a materialman's lien against the Project for the

principal sum of \$18,489.22 plus interest at a rate of 18% per annum from November 19, 2008

until the materialman's lien is paid in full.

3. Costs are hereby taxed as have been previously paid in this adversary proceeding

by Quality Properties, L.L.C. to the United States Bankruptcy Court for the Northern District of

Alabama, Eastern Division. Each party is to bear its own attorney fees.

4. Sherwin's claims seeking a monetary judgment against Pine Apple Conveyor

Service, Inc. that were asserted in counts one and two of the State Court complaint were

previously remanded by this Court to State Court are still being adjudicated in the Circuit Court

of Shelby County, Alabama.

5. Sherwin's request for a determination that the materialman's lien on the Project is

a first-priority lien and is prior in right to the subsequent mortgage granted by Quality Properties,

L.L.C. in favor of First National Bank of Talladega is hereby DENIED.


