KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of June, 2007, James M. Scott and Leigh-Ann Scott, also known as Leigh A. Scott, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Quicken Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20070620000289670, said mortgage having subsequently been transferred and assigned to M&T Bank, by instrument recorded in Instrument Number 20121001000374160, in the aforesaid Probate Office ("Transferee"); and

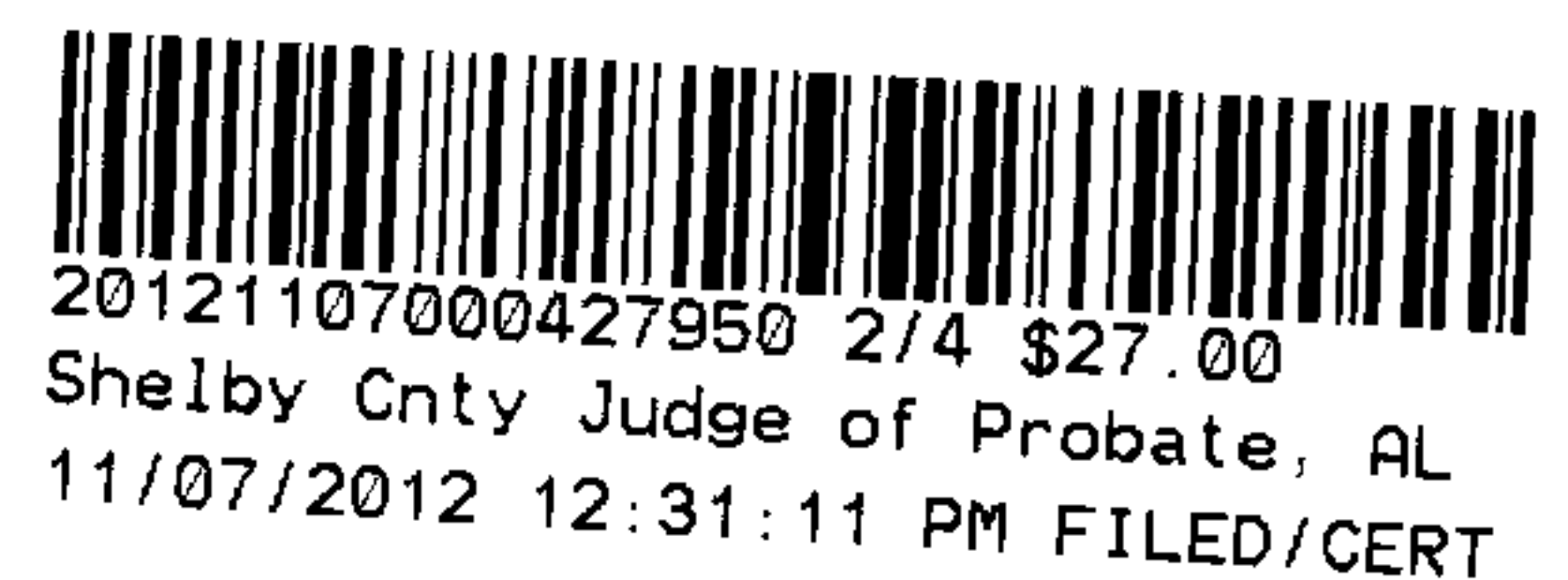

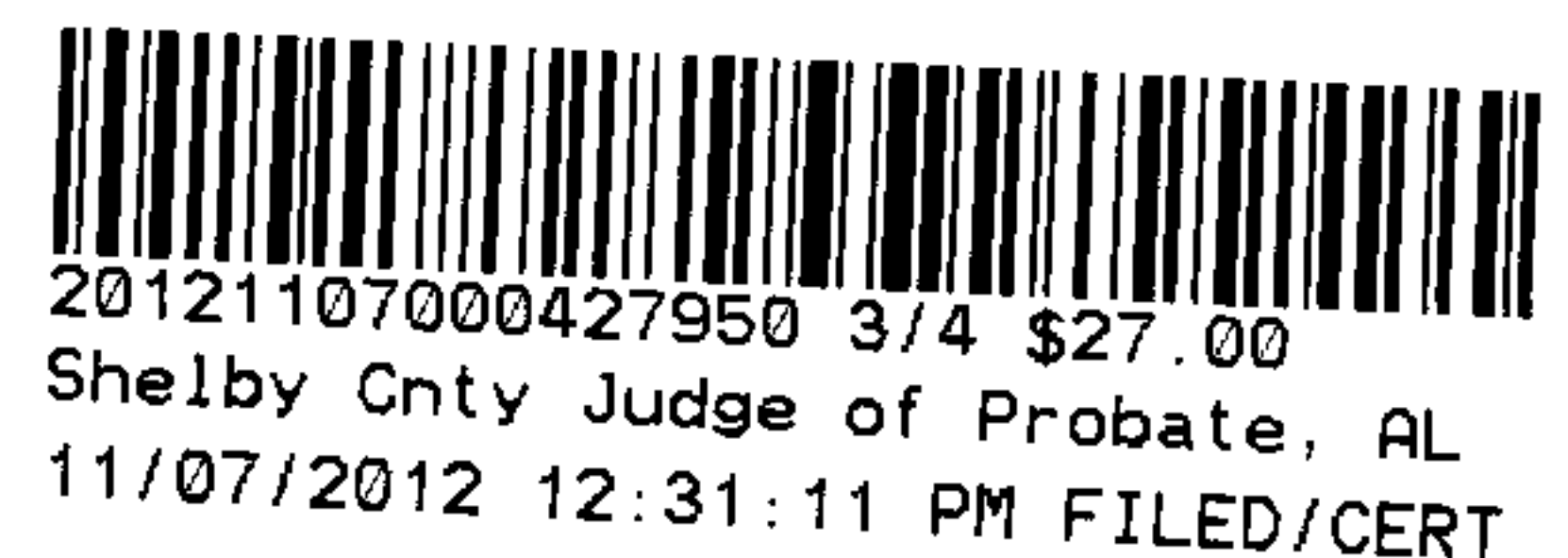
