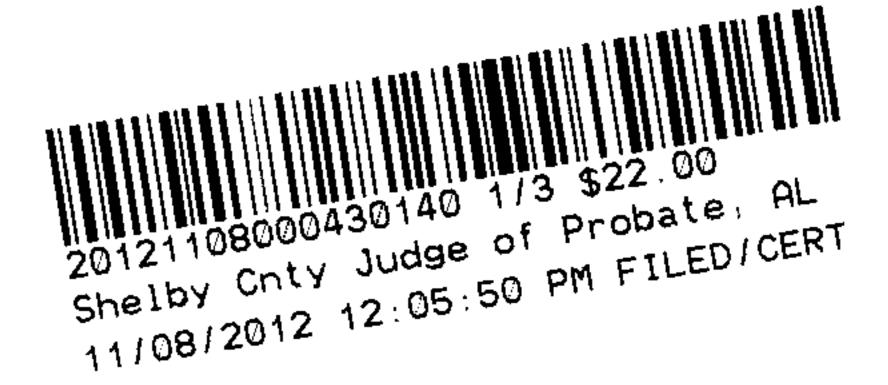

## MORTGAGE FORECLOSURE DEED
