FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of October, 2001, John D. Nixon, Jr., joined by Laura J. Nixon, his wife, executed that certain mortgage on real property hereinafter described to Regions Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 2001-48500 , said mortgage having subsequently been transferred and assigned to Everbank , by instrument recorded in Inst. No. 20080916000366570, in the aforesaid Probate Office ("Transferee"); and
