KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of May, 2011, Laura B. Turner, a married woman and husband, Patrick J. Turner, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for ERA Mortgage, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20110614000175180, said mortgage having subsequently been transferred and assigned to PHH Mortgage Corporation, by instrument recorded in Instrument Number: 20121008000384970, in the aforesaid Probate Office ("Transferee"); and

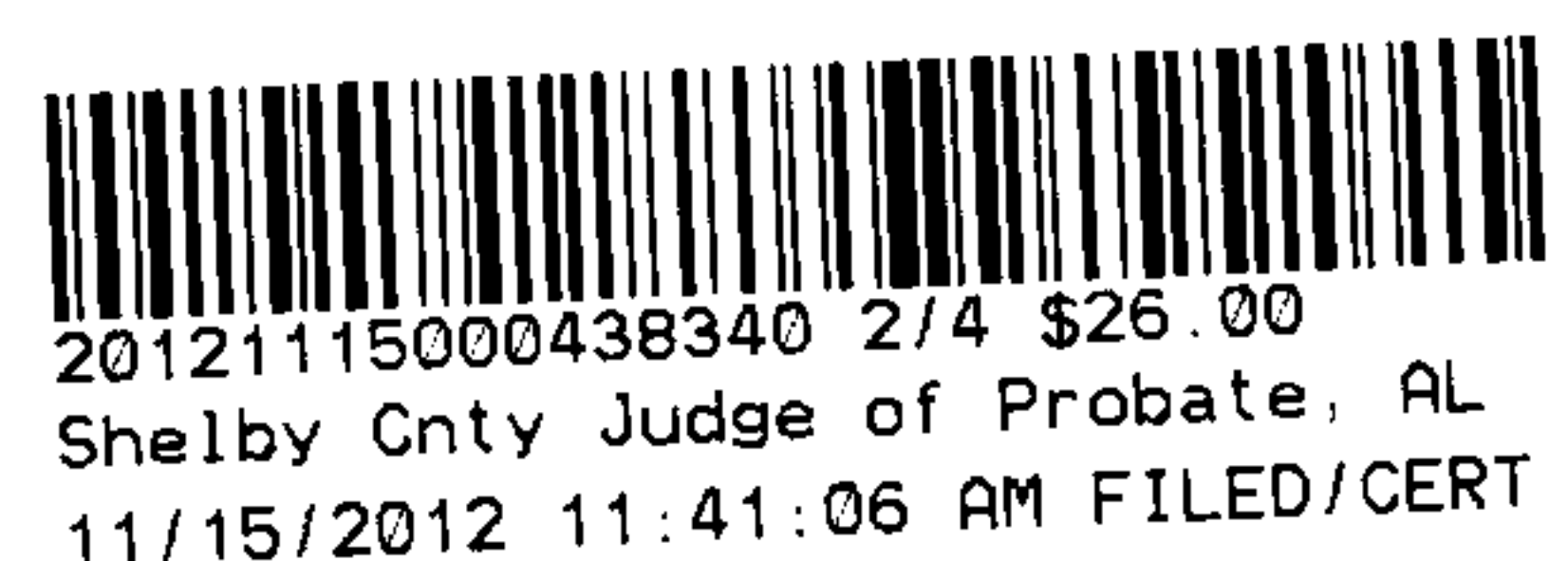

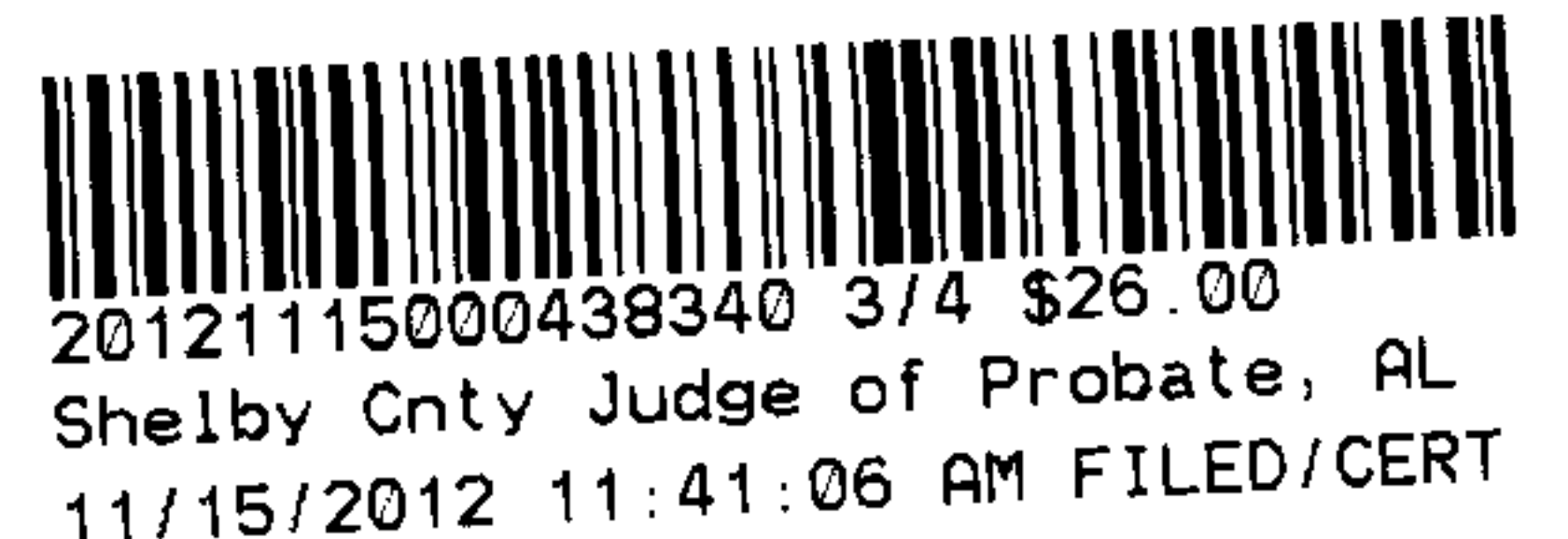
