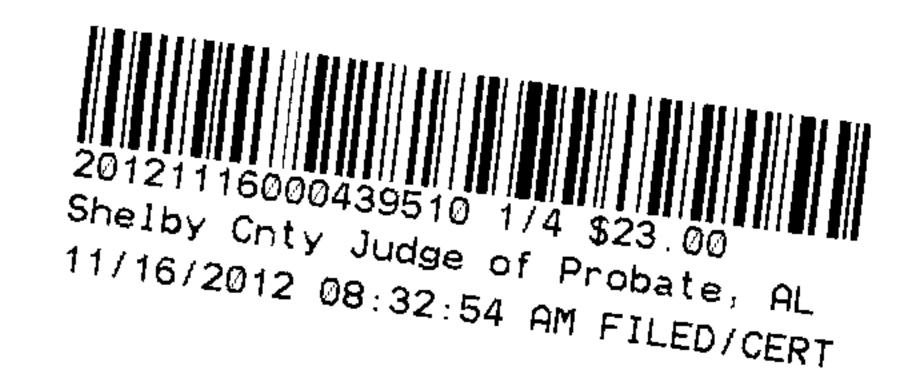
## KNOW ALL MEN BY THESE PRESENTS
