

AUCTIONEER'S DEED

WHEREAS, Michael W. Patton and Riki L. Patton, husband and wife executed a mortgage to Mortgage Electronic Registration Systems, Inc. 



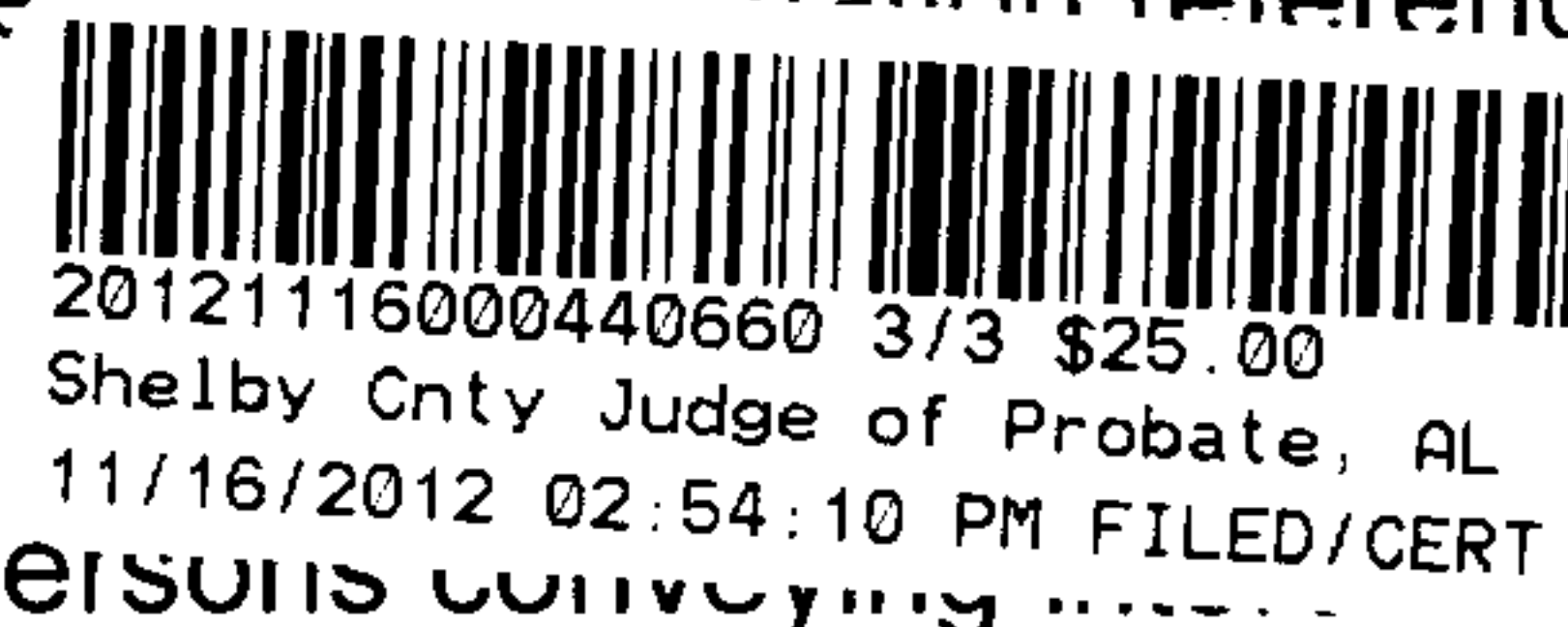
