Commence at the southwest corner of Section 17, Township 21, Range 2 West; thence North 01 degree 49 minutes 47 seconds East along the West line of said section for 305.53 feet to a point on the point on North Line of Shelby County Road No. 87, said point being the Point of Beginning; thence turn 63 degrees 05 minutes 41 seconds right and run along right of way line North 65 degrees 05 minutes 19 seconds East for 802.38 feet; Thence turn 56 degrees 24 minutes 21 seconds left and run along said right of way line North 08 degrees 40 minutes 58 seconds East for 94.69 feet to a point on the westerly right of way line of U.S Highway No.31; thence turn 42 degrees 42 minutes 28 seconds left and run along said right of way line North 34 degrees 01 minute 30 seconds West for 366.04 feet; thence turn 84 degrees 59 minutes 06 seconds left and run South 60 degrees 59 minutes 24 seconds West for 952.33 feet to the easterly right of way line of C.S.X. Railroad; thence turn 82 degrees 59 minutes 24 seconds left and run South 22 degrees 00 minutes 00 seconds East along said right of way line 372.71 feet to the point of intersection of said C.S.X. Railroad right of way and the North line of Shelby County Road No. 87; thence turn 92 degrees 54 minutes 41 seconds left and run North 65 degrees 05 minutes 19 seconds East along the North right of way line of Shelby County Road No. 87, North 65 degrees 05 minutes 19 seconds East for 172.03 feet back to the Point of Beginning.
