I know of my own knowledge that Sarah Shaw Cook, grantee in that certain deed recorded in Deed Book 255, Page 480, in the Probate Office of Shelby County, Alabama, died on or about February 22, 2008, in Shelby County, Alabama. She had a Will, but her only child does not intend to Probate it. I know she was unmarried at the time of her death and she had only one child, Carl Alexander Cook II.
