General Durable Power of Attorney of John Mobley

 - Tax Returns and Reports. To prepare, sign, and file separate or joint income, gift iv. and other tax returns and other governmental reports and documents; to consent to any gift; to file any claim for tax refund; and to represent me in all matters before the Internal Revenue Service;
 - Safe Deposit Boxes. To have access to any safety deposit box registered in my ٧. name alone or jointly with others, and to remove any property or papers located therein;
 - Proxy Rights. To act as my agent or proxy for any stocks, bonds, shares, or other VÌ. investments, rights, or interests I may now or hereafter hold;
 - Legal and Administrative Proceedings. To engage in any administrative or legal VII. proceedings or lawsuits in connection with any matter herein;
 - Transfers in Trust. To transfer any interest I may have in property, whether real VIII. or personal, tangible or intangible, to the trustee of any trust that I have created for my benefit;

- ix. Delegation of Authority. To engage and dismiss agents, counsel, and employees in connection with any matter, upon such terms as my agent determines;
- x. Health Care Decisions. To make any necessary health care decisions for me and on my behalf should I become unable to make such decisions, including the power and authority to request, review and receive any information, verbal or written, regarding my physical or mental health; to execute on my behalf any releases or other documents that may be required in order to obtain this information; to consent to the disclosure of this information; and, where necessary to implement the health care decisions that my agent is authorized to make by this document, the Agent has the power and authority to execute any necessary waiver or release from liability required by a hospital or physician.
- 3) Durability. This durable Power of Attorney shall not be affected by my disability, incompetency, or incapacity, except as provided by law, and shall continue in effect until revoked by me in writing.
- A) Reliance by Third Parties. Third parties may rely upon the representations of the Agent as to all matters regarding powers granted by the Agent. No person who acts in reliance on the representations of the Agent or the authority granted under this Power of Attorney shall incur any liability to me or to my estate for permitting the Agent to exercise any power prior to actual knowledge that the Power of Attorney has been revoked or terminated by operation of law or otherwise.
- 5) Indemnification of Agent. No agent named or substituted in this Power of Attorney shall incur any liability to me for acting or refraining from acting under this power, except for such agent's own misconduct or negligence.
- 6) Original Counterparts. Photocopies of this signed Power of Attorney shall be treated as original counterparts.
- 7) Substitute Agent. I appoint my daughter Ann Robertson residing at 728 Preserve Way, Birmingham, Alabama, to serve as substitute agent in place of Jane Mobley if Jane Mobley is unable to serve. A statement signed by the substitute agent affirming that Jane Mobley is unable to serve shall be sufficient to establish that the agent is unable to serve.
