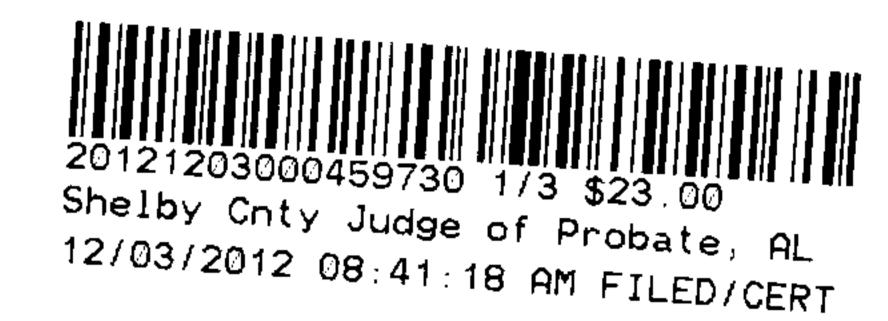

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on April 12, 2007, Erika Mitchell, Party of the First Part, executed a certain mortgage to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for GMAC Mortgage, LLC dba ditech.com, its successors and assigns, party of the second part which said mortgage is recorded in Instrument No. 20070508000216760, in the Office of the Judge of Probate of Shelby County, Alabama.
