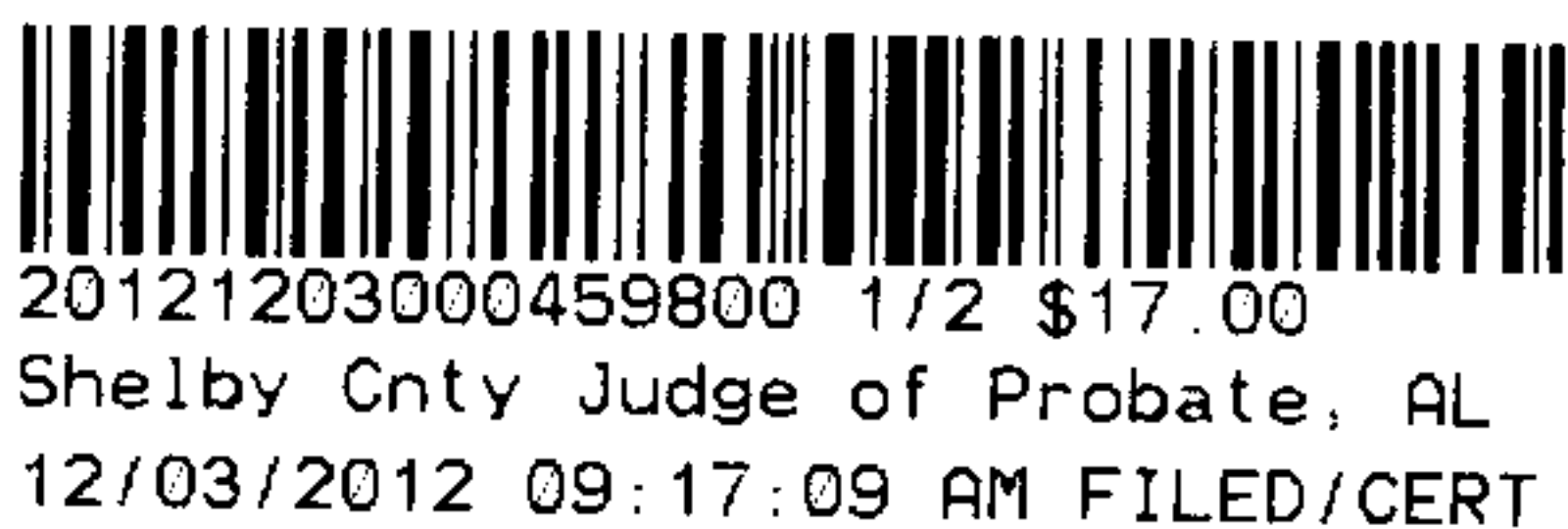

STATUTORY WARRANTY DEED

Beginning at the Southeast corner of the NW1/4. of NE1/4 of Section 18, Township 21, Range 2 West and run thence North 256 feet to the point of beginning; thence continue North 217 feet; thence run North 87 deg. 15 min. West 632 feet to a point on U. S. Highway 31 R/O/W; thence South 40 deg. 30 min. East 316 feet; thence North S9 deg. 45 min. East 440 feet to the point of beginning. Containing 2 acres, more or less. Grantor's name and mailing address - provide the name of the person or persons conveying interest to property and their current mailing address.

Grantee's name and mailing address - provide the name of the person or persons to whom interest to property is being conveyed.

Date of Sale - the date on which interest to the property was conveyed.
