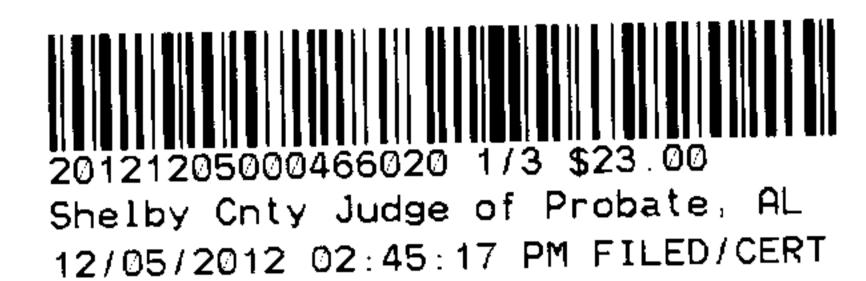

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on June 29, 2007, Douglas R. Steele aka Doug Steele, a single man, Party of the First Part, executed a certain mortgage to Mortgage Electronic Registration Systems, Inc., acting solely as a nominee for Suntrust Mortgage Inc., its successors and assigns, party of the second part which said mortgage is recorded in Real Property Book 2007, Page 318630, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to SunTrust Bank in Instrument No. 20111102000329020; and
