The undersigned, desiring to become a nonprofit corporation for the purposes of carrying on the activities hereinafter stated and set forth, do hereby make and file these Articles of Incorporation pursuant to the General Provisions of the "Alabama Nonprofit Corporation Act" of Alabama, (Sections 10A-3-1.01, et. seq., Code of Alabama 1975) and any amendments thereto, stating and certifying as follows:

FIRST: The name of the corporation is:

SECOND: The corporation is formed for the following objects:

- a. To provide charitable services and assistance to needy children and abused women.
- b. To solicit and receive gifts and donations of money and all kinds of property to be used for the purpose of assisting needy children and abused women.

 To acquire by purchase, subscription or otherwise, and to receive, hold, own,

guarantee, sell, assign, exchange, transfer, mortgage, pledge or otherwise dispose of or deal in and with any of the shares of the capital stock, or any voting trust certificates in respect of the shares of capital stock, script, warrants, rights, bonds, debentures, notes, trust receipts and other securities, obligations, choses in action and evidences of indebtedness or interest issued or created by any corporations, joint stock companies, syndicates, associates, firms, trusts or persons, public or private, or by the Government of the United States of America, or by any foreign government, or by any state, territory, province, municipality or other political subdivision or by any Government agency (even to the extent of all or a controlling interest in the stock of another corporation, or even to the extent of all or any part of an issue of corporation stock, voting trust certificate, script, warrants, rights, bonds, debentures, notes, trust receipts, and other securities, obligations, or choses in action), and as owner thereof to possess and exercise all the rights, powers and privileges of ownership, including the right to execute consents and vote thereon, and to do any and all acts and things necessary or advisable for the preservation, protection, improvement and enhancement in value thereof.

- To merge or consolidate with any nonprofit corporation in such manner as may be permitted by law.
- To enter into, make, and perform contracts of every kind and description with any person, firm, association, corporation (including, without limiting the generality of the foregoing, any corporation in which this corporation

ELEVENTH: Any person made a party to any action, suit or proceeding by reason of the fact that he, his testator, or intestate, is or was a director, officer or employee of this corporation, or of any corporation which he served as such at the request of this corporation, shall be indemnified by the corporation against the reasonable expenses, including attorney's fees, actually and necessarily incurred by him in connection with the defense of such action, suit or proceeding, or in connection with any appeal therein, except in relation to matters as to which it shall




