

ARTICLES OF ORGANIZATION

OF

PFP LLC

Pursuant to the Provisions of the Code of Alabama, Title 10A, Chapter 5, Articles 1, et. seq., the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

The name of the Limited Liability Company is: PFP LLC (hereinafter referred to as the "Company").

ARTICLE II

The Company shall begin on the date of the filing of the Article of Organization with the Probate Judge and shall continue perpetually, unless sooner terminated as provided in the Operating Agreement.

ARTICLE III

PURPOSES

(a) The Company has been organized to engage in any lawful act or activity for which a limited liability company may be organized under the Alabama Limited Liability Company Act.

ARTICLE IV

REGISTERED AGENT/OFFICE

The location and street address of the initial registered office shall be 5230 Cahaba Valley CV, Birmingham, Alabama 35242, and its initial registered agent at such address shall be Paul Franklin Polhill.

ARTICLE V

<u>INITIAL MEMBERS</u>

ADMISSION OF NEW MEMBERS

The initial Member(s) have the right to admit additional Members, upon such terms and conditions as may be agreed upon, by unanimous written consent of the initial Member(s) of the Company.

CESSATION OF MEMBERSHIP

The cessation of membership of one or more member(s) will <u>not</u> result in the dissolution of the Company.

ARTICLE VIII

MANAGEMENT

The Company shall be managed by the initial Member(s) until such time as their successors are elected and qualify for service.
