LEGAL DESCRIPTION

A parcel of land situated in the Southwest Quarter of the Northwest Quarter of Section 14, Township 18 South, Range 1 East, Shelby County, Alabama, being more particularly described as follows:

Commence at an angle iron locally accepted to be the Southwest corner of said Quarter-Quarter Section; thence run in an Easterly direction along the South line of said Quarter-Quarter Section for a distance of 349.89 feet to an iron pin set at the point of beginning; thence continue along last stated course for a distance of 120.60 feet to a ¾-inch open top iron found; thence turn an angle to the left of 87 degrees 25 minutes 42 seconds and run in a Northeasterly direction for a distance of 420.78 feet to an iron pin found; thence turn an angle to the left of 89 degrees 43 minutes 17 seconds and run in a Northwesterly direction for a distance of 210.98 feet to a 2-inch open top iron found; thence turn an angle to the right of 103 degrees 14 minutes 28 seconds and run in a Northeasterly direction for a distance of 812.46 feet to an iron pin found on the Southeast right of way of Shelby County Highway #45; thence turn an angle to the left of 78 degrees 36 minutes 21 seconds and run in a Northwesterly direction along the Southwest right of way line of said Shelby County Highway #45 for a distance of 40.08 feet to a ½-inch rebar found; thence turn an angle to the left of 101 degrees 35 minutes 08 seconds and run in a Southwesterly direction for a distance of 751.06 feet to a ½-inch rebar found; thence turn an angle to the right of 79 degrees 56 minutes 01 seconds and run in a Northwesterly direction for a distance of 42.08 feet to an iron pin set; thence turn an angle to the right of 119 degrees 40 minutes 11 seconds and run in a Southeasterly direction for a distance of 534.64 feet to the point of beginning.
