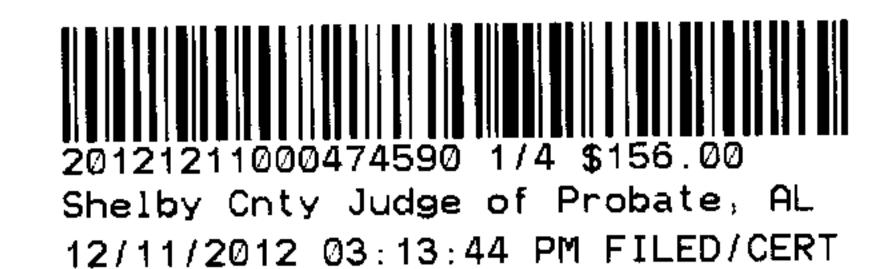
CERTIFICATE OF FORMATION

Pursuant to the Alabama Limited Liability Company Law as set forth in Chapter 1 and Chapter 5 of the Alabama Business and Nonprofit Entity Code, the undersigned hereby adopts the following Certificate of Formation:

ARTICLE I NAME

The name of the limited liability company is Cahaba Dermatology & Skin Health Center, LLC (the "Company").

ARTICLE II TYPE

The Company is a limited liability company.

ARTICLE III DURATION

The Company shall have perpetual duration unless it is dissolved and its affairs wound up in accordance with the Alabama Business and Nonprofit Entity Code or the Operating Agreement of the Company.

ARTICLE IV PURPOSES

The purposes for which the Company is formed are:

- (a) To engage in, conduct and carry on a dermatology and skin health medical practice, and to render professional and other services ancillary thereto;
- (b) To engage in any lawful activities permitted to limited liability companies by the applicable laws and statutes for such entities of the State of Alabama.

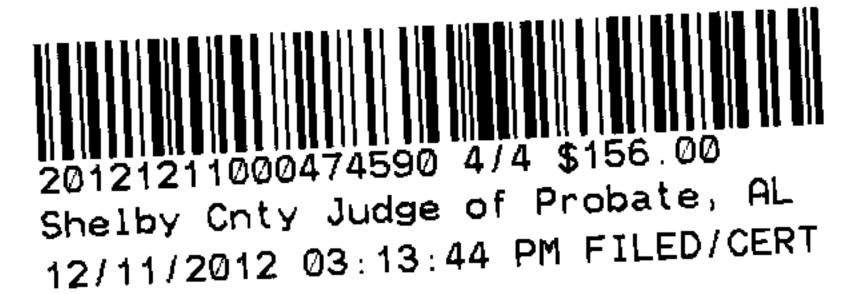
