WHEREAS, heretofore on April 15, 2008, **Donald Lee Martin, Jr. and Tina Michelle Russell Martin, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Impact Mortgage Group, Inc. its successors and assigns, party of the second part** which said mortgage is recorded in Instrument No. 20080425000170140, in the Office of the Judge of Probate of Shelby County, Alabama. WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of Fannie Mae ("Federal National Mortgage Association")


