

Order and Judgment

This cause came before the Court on a Motion for Default Judgment filed by Plaintiff Forest Park Specialty, L.L.C. ("Plaintiff") against Defendant Wallace Sears ("Defendant").

Sears having been duly served by certified mail and not being an infant or an unrepresented incompetent person and having failed to plead or otherwise defend, and there being no just reason for delay in the entry of judgment against Sears, it is therefore ORDERED, ADJUDGED, DECLARED, and DECREED as follows:

- 1. That the Motion for Default Judgment filed by Plaintiff is hereby granted and judgment is entered against Defendant for failure to answer or otherwise defend as to Plaintiff's Complaint.
- 2. That Defendant shall pay a total of \$55,334.12 to Plaintiff consisting of \$48,564.00 in damages, plus prejudgment interest in the amount of \$1,405.03, plus cost for filing fee in the amount of \$365.09, and a reasonable attorneys' fee in the amount of \$5,000, which such attorneys' fee is authorized by the Promissory Note executed by Defendant and made the basis of Plaintiff's Complaint. Costs taxed to defendant.
