Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

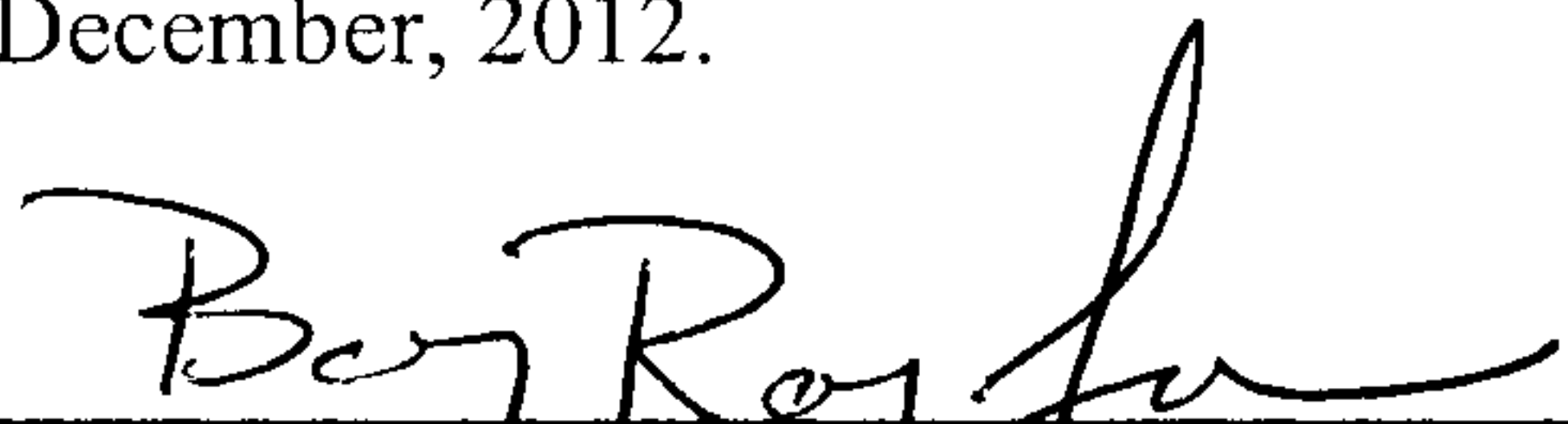
\$425,675.00 of the purchase price herein above has been paid by a purchase money mortgage loan closed simultaneously herewith.

Barry Faulkner and Barry Ray Faulkner are one and the same person.

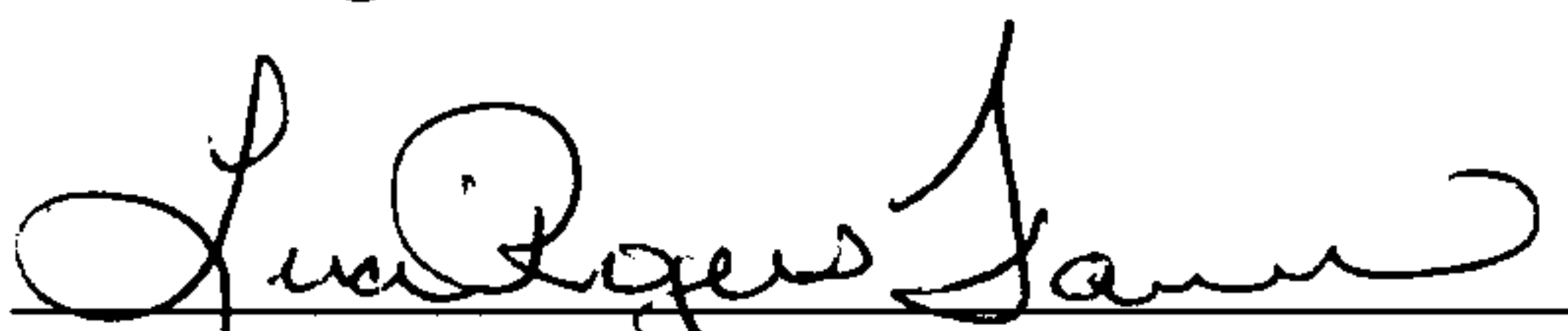
