THIS AGREEMENT is made and entered into on this 23rd day of October, 2012, by Regions Bank (Hereinafter referred to as "Regions Bank") in favor of JP MOORGAN CHASE BANK, N.A., its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions Bank loaned to Andrea L Koontz and Randy L Koontz (the "Borrower", whether one or more) the sum of \$40,000.00. 
