THIS AGREEMENT is made and entered into on this 21st day of November, 2012, by Regions Bank (Hereinafter referred to as "Regions Bank") in favor of MERS INC., AS NOMINEE FOR QUICKEN LOANS, INC, its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions Bank loaned to Stuart N Cammack and Rebecca R Cammack* (the "Borrower", whether one or more) the sum of \$140,000.00. 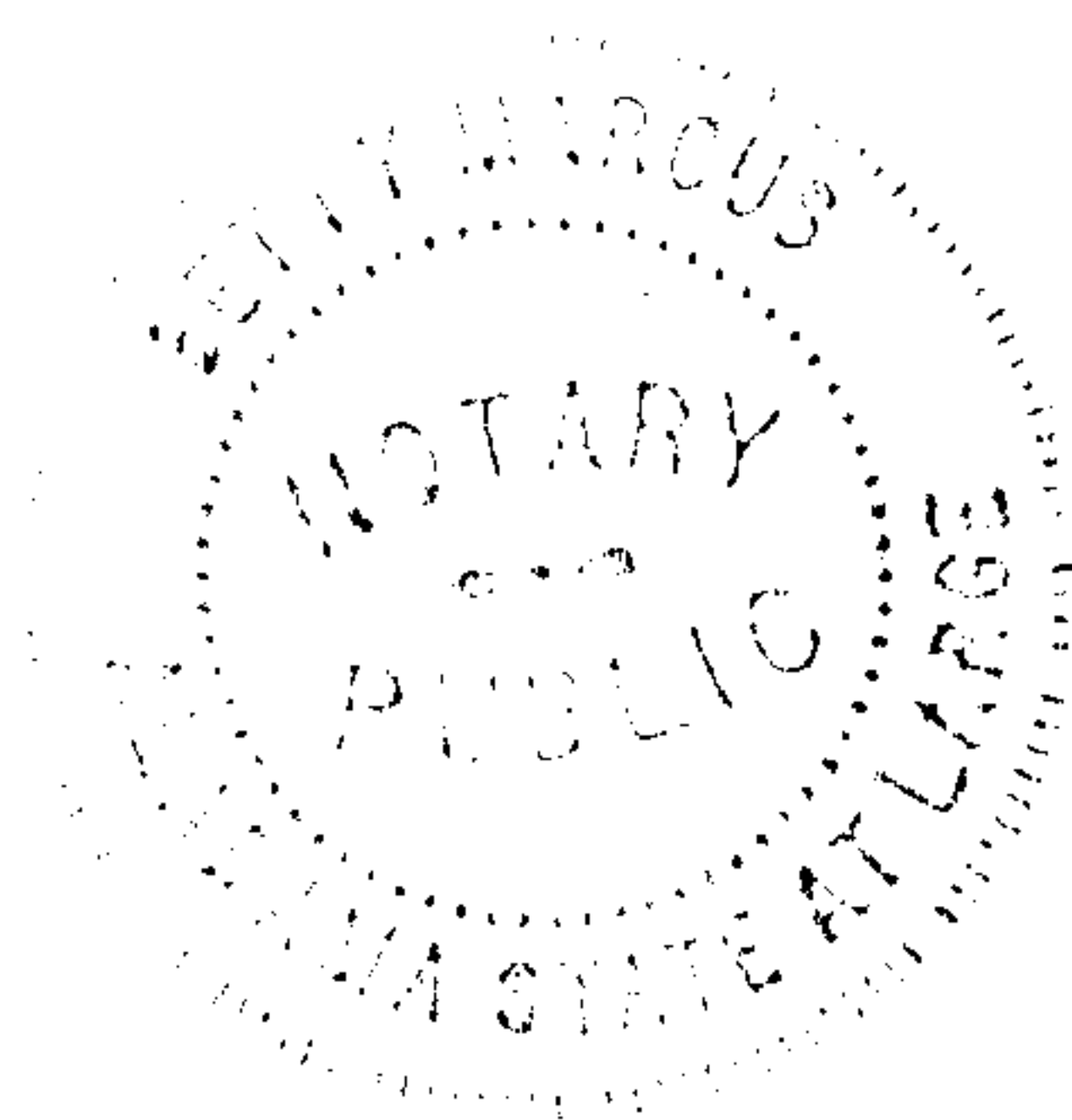
