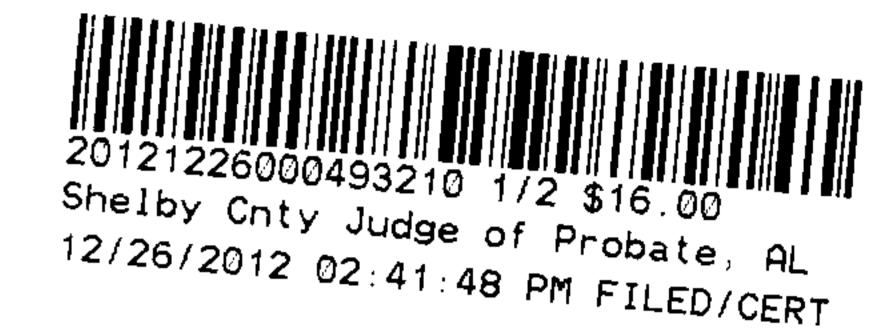

Subordination Agreement

THIS AGREEMENT is made and entered into on this 5th day of December, 2012, by Regions Bank (Hereinafter referred to as "Regions Bank") in favor of WELLS FARGO HOME MORTGAGE, N.A., its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions Bank loaned to Anthony S Shunnarah and Michelle C Shunnarah (the "Borrower", whether one or more) the sum of \$45,400.00. 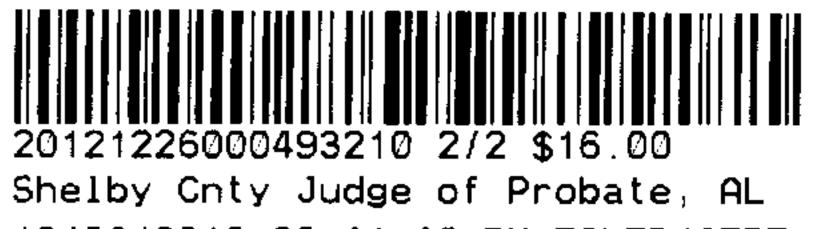
