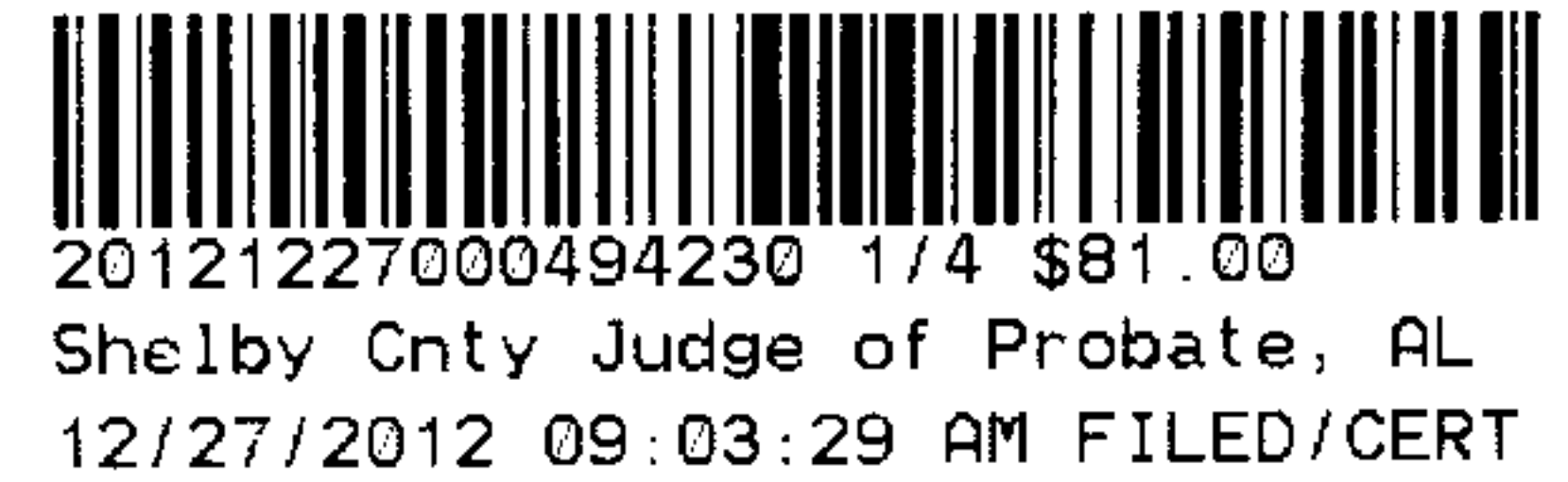


**FIRST AMENDMENT TO THE

No other provision of the original Articles of Organization of AFK Land, LLC shall be changed by this Amendment.


