KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of January, 2007, Nova P. Eastis, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Countrywide Bank, N.A., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070205000051820, said mortgage having subsequently been transferred and assigned to Deutsche Bank National Trust Company, as Trustee for the Holders of the BCAP LLC Trust 2007-AA2, by instrument recorded in Instrument Number 20121101000419570, in the aforesaid Probate Office ("Transferee"); and

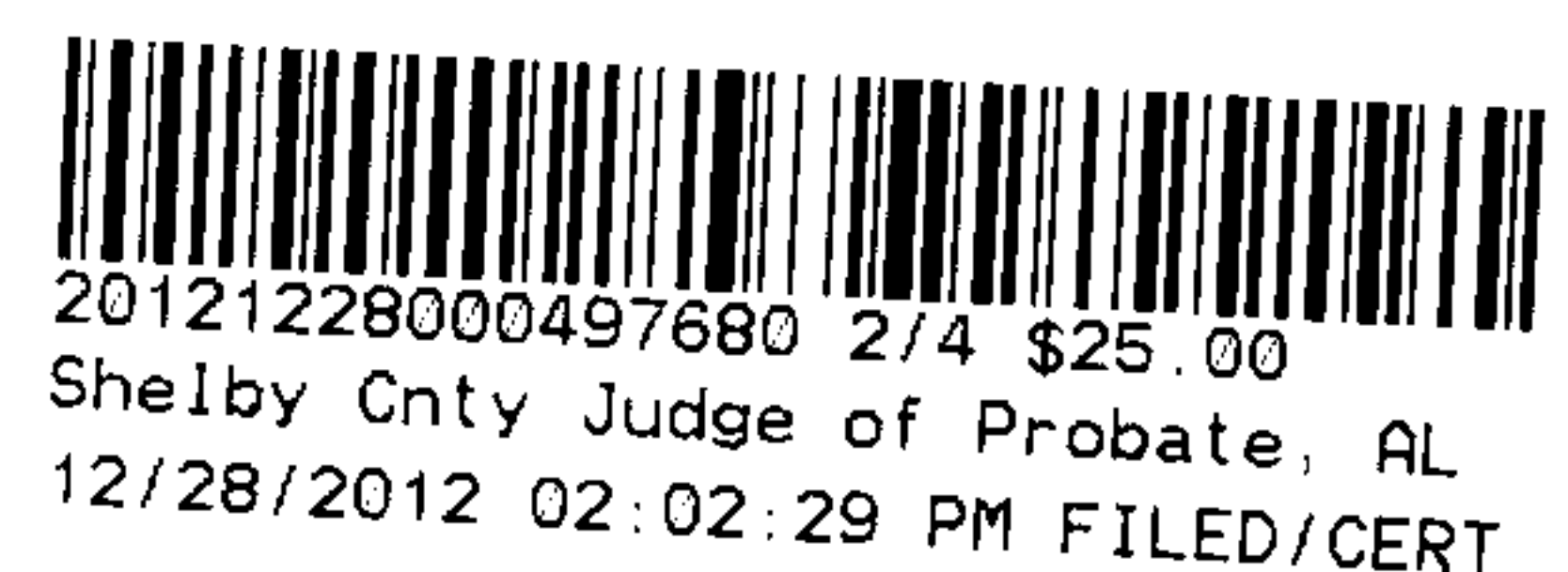
