KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of February, 2005, Thomas Landry and Angela F. published in Shelby County, Alabama, in its issues of November 21, 2012, November 28, 2012, and December 5, 2012; and

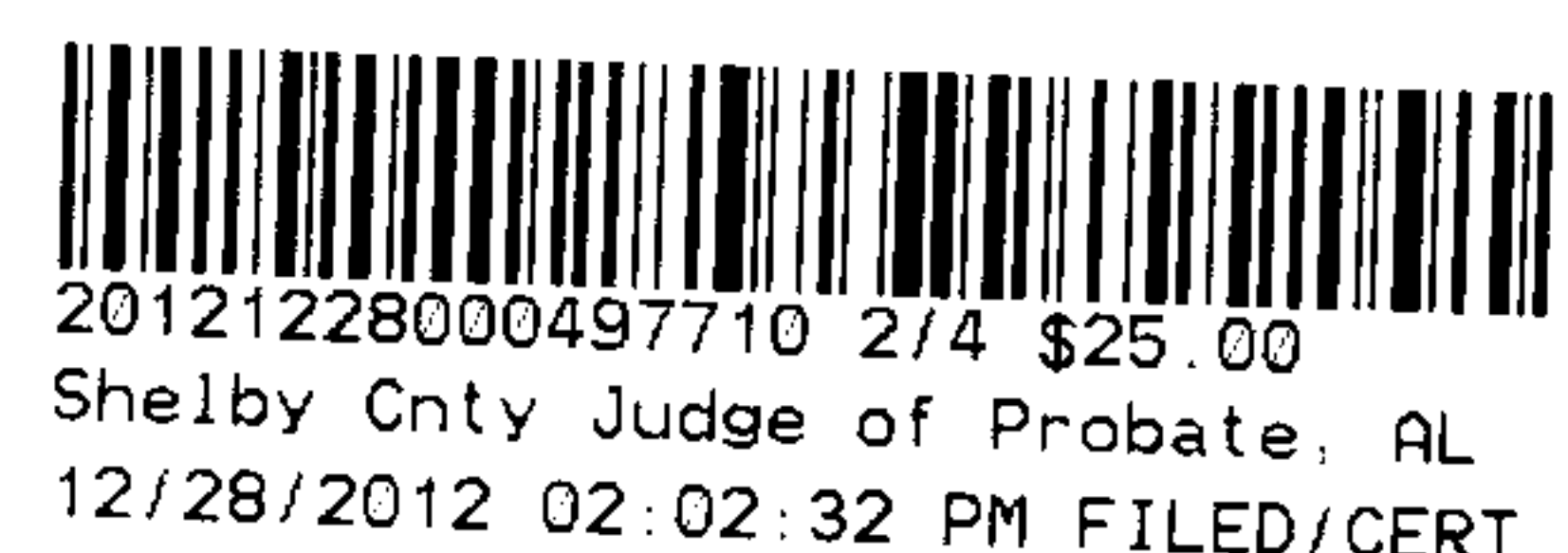

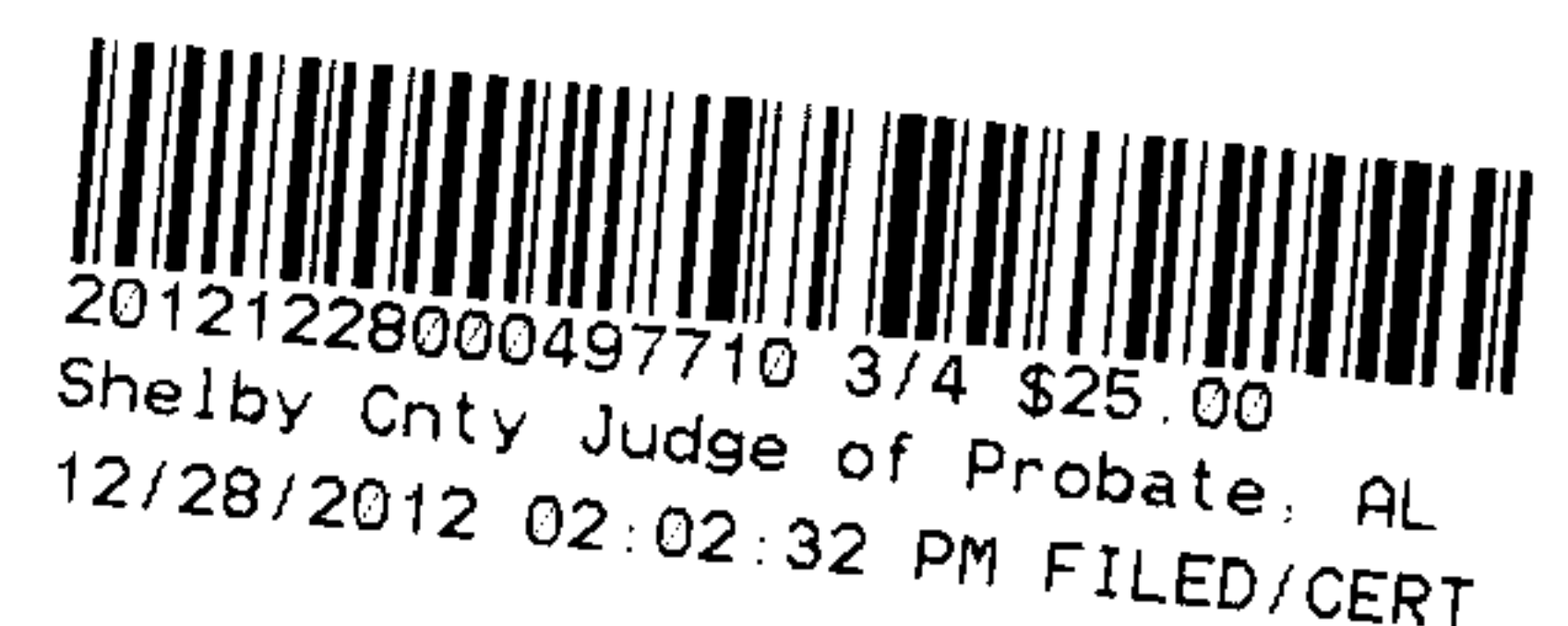
