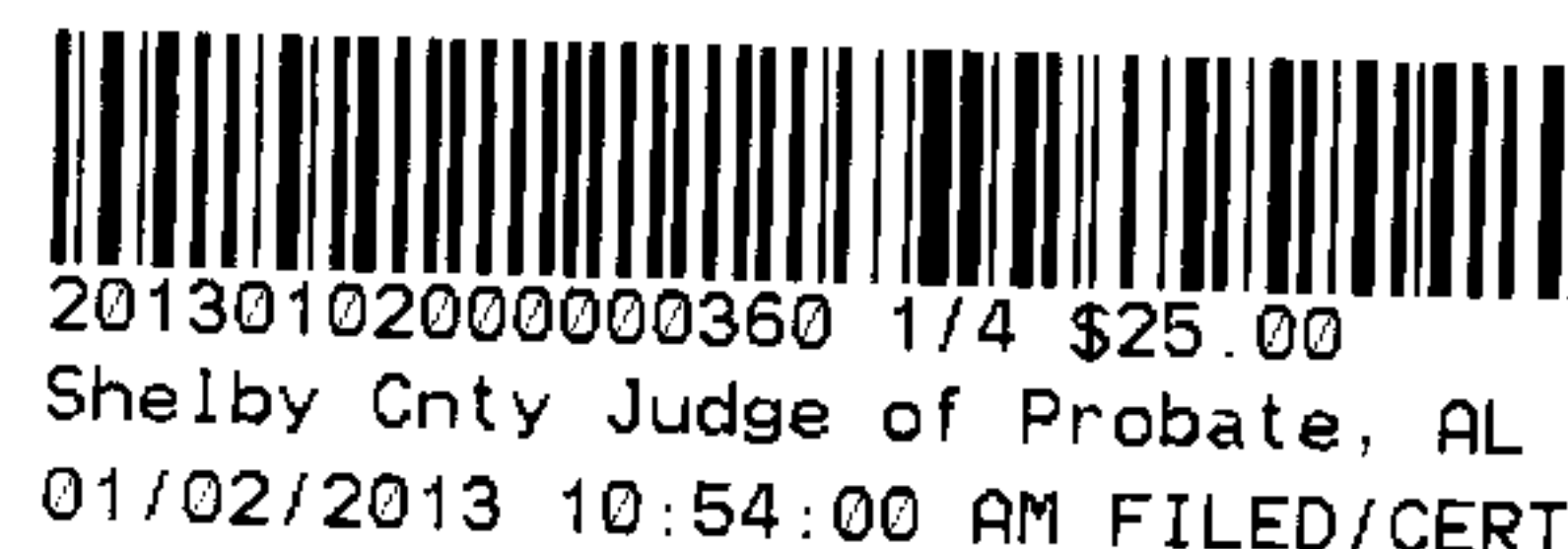
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 20th day of March, 2009, Terry E. Crain, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for United Wholesale Mortgage, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090327000113810, said mortgage having subsequently been transferred and assigned to Bank of America, N.A. successor by merger to BAC Home Loans Servicing LP fka Countrywide Home Loans Servicing, LP, by instrument recorded in Instrument Number 20120409000120310, in the aforesaid Probate Office ("Transferee"); and

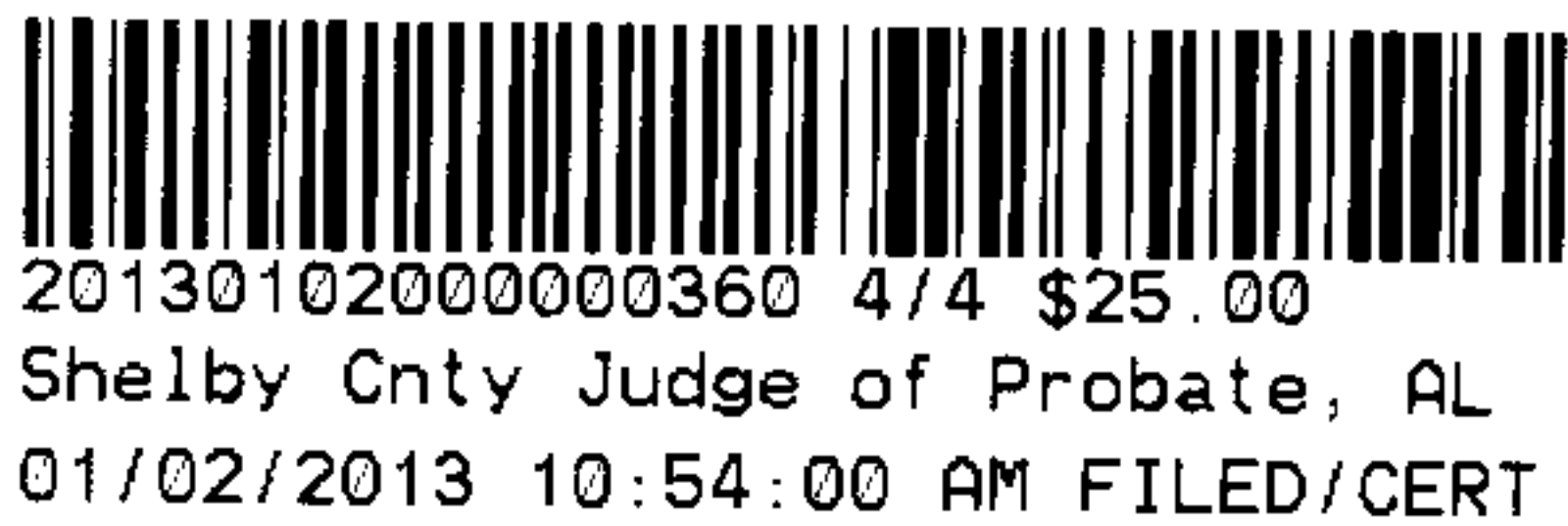
