The undersigned, for the purpose of forming a limited liability company under Title 10A-5-1.01 *et seq.*, Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Law"), hereby files the following Certificate of Formation with the probate office of the county in which the initial registered office of the limited liability company will be located, and hereby affirm the facts stated herein are true and correct:

- 1. The name of the limited liability company is ALL-STAR INVESTMENT PROPERTIES, LLC (the "Company").

If no valid Operating Agreement exists at any time, the internal affairs of the Company shall be conducted in accordance with the Alabama Limited Liability Company Law.
