

**ARTICLES OF ORGANIZATION
OF WORLDWIDE DO IT, LLC**

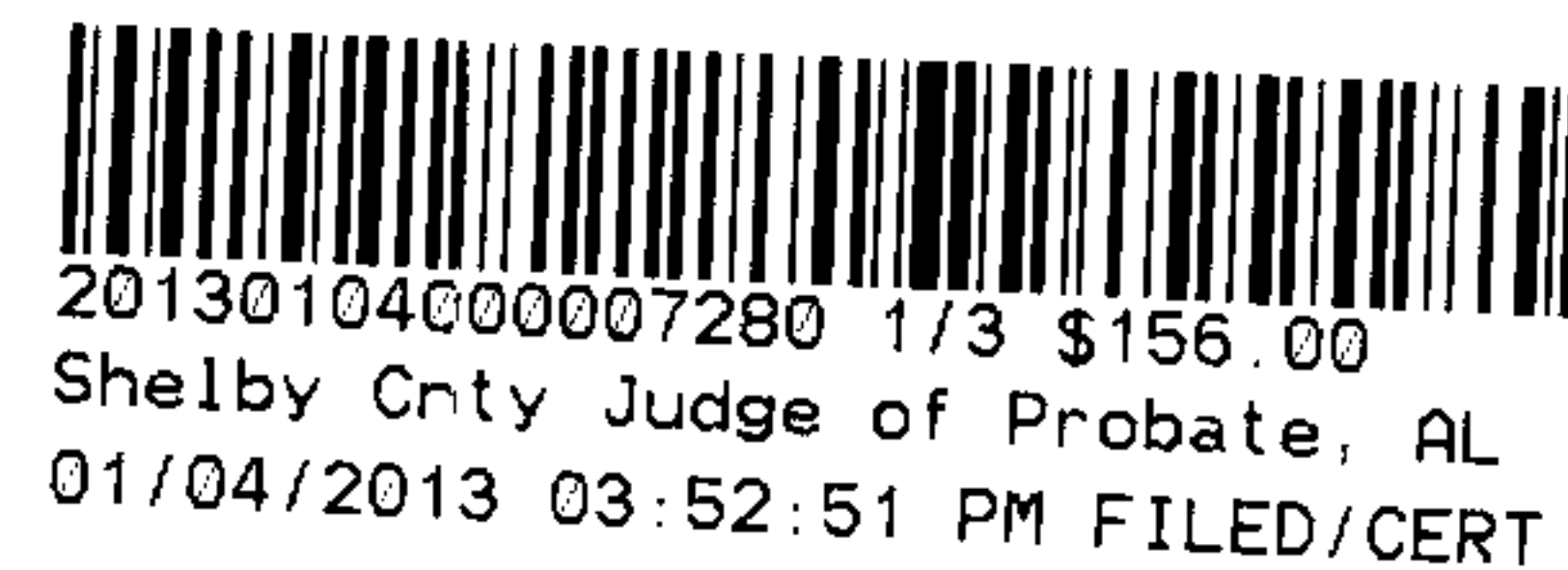

**ARTICLE I

DURATION**

The period of the duration is perpetual.



**ARTICLE III
PURPOSES**

limited to this sole purpose.

**ARTICLE IV

Shall be granted upon the majority election of the present members.


ARTICLE VIII
