

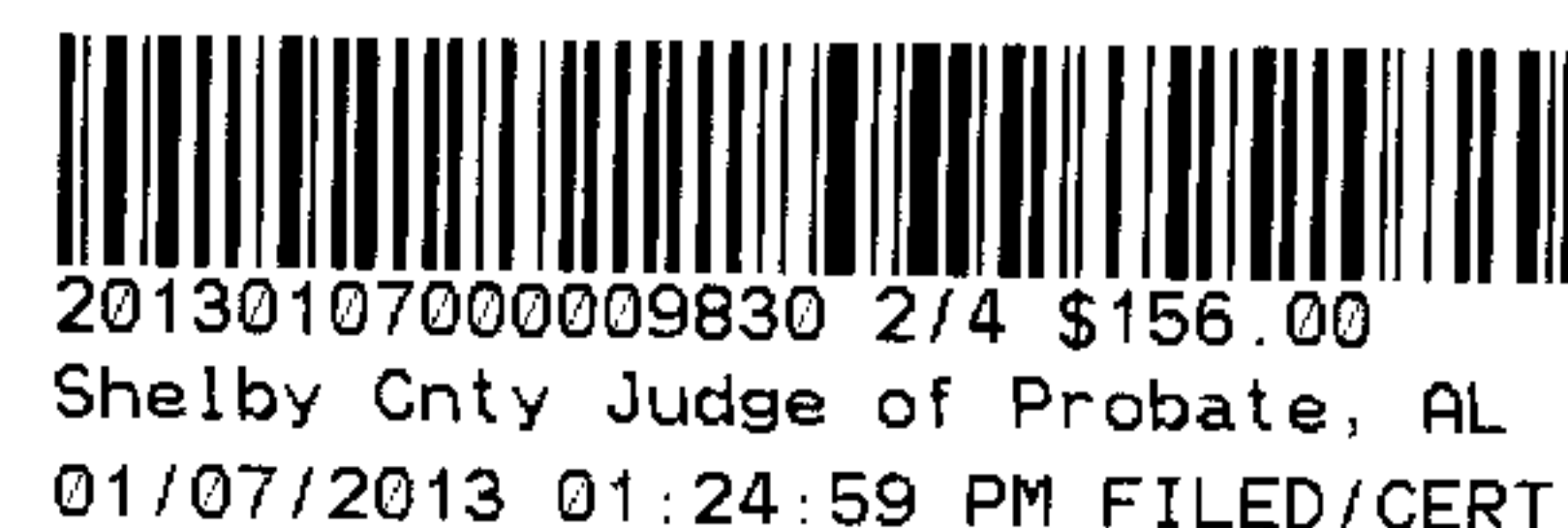
ARTICLE TEN

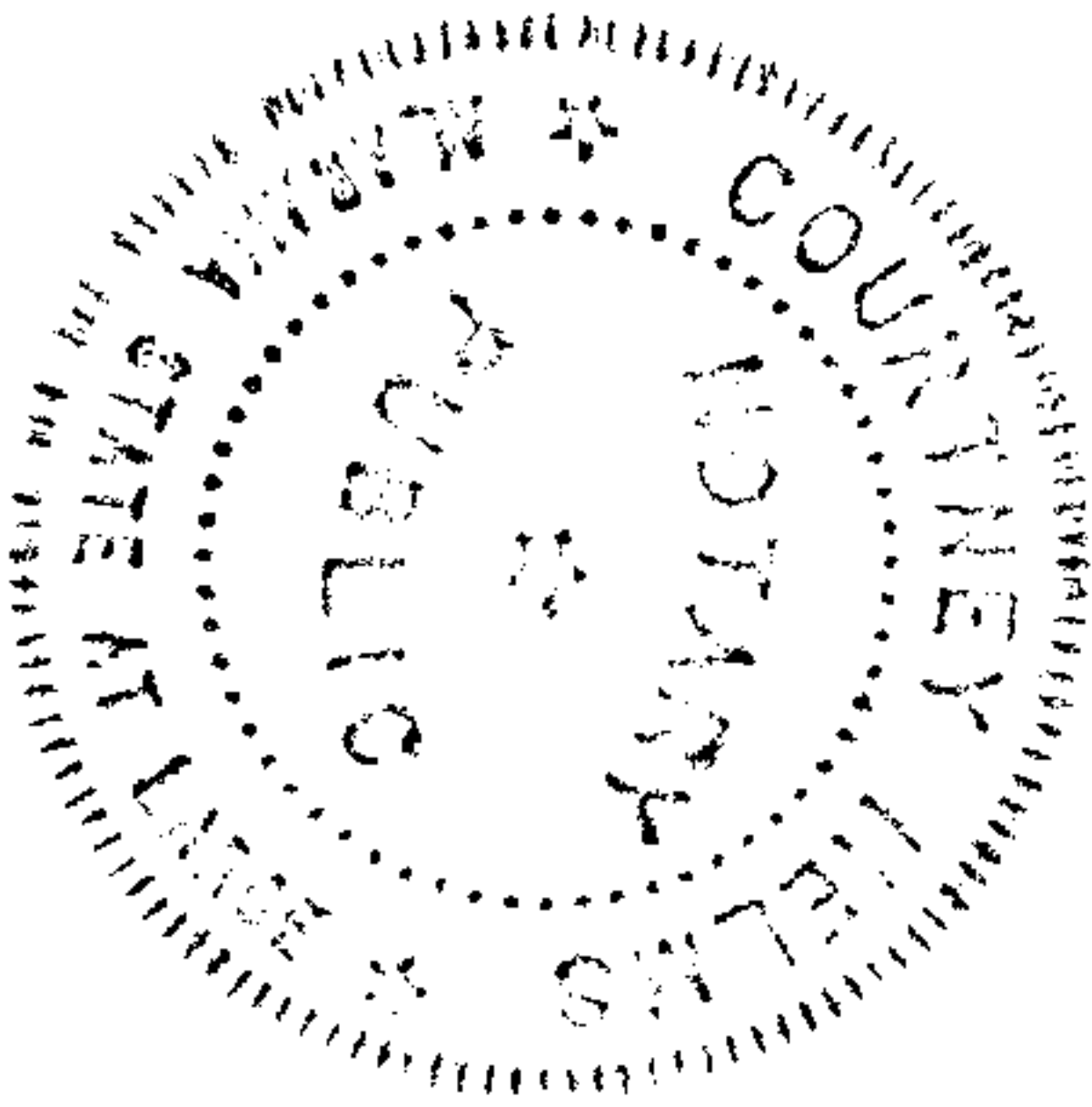

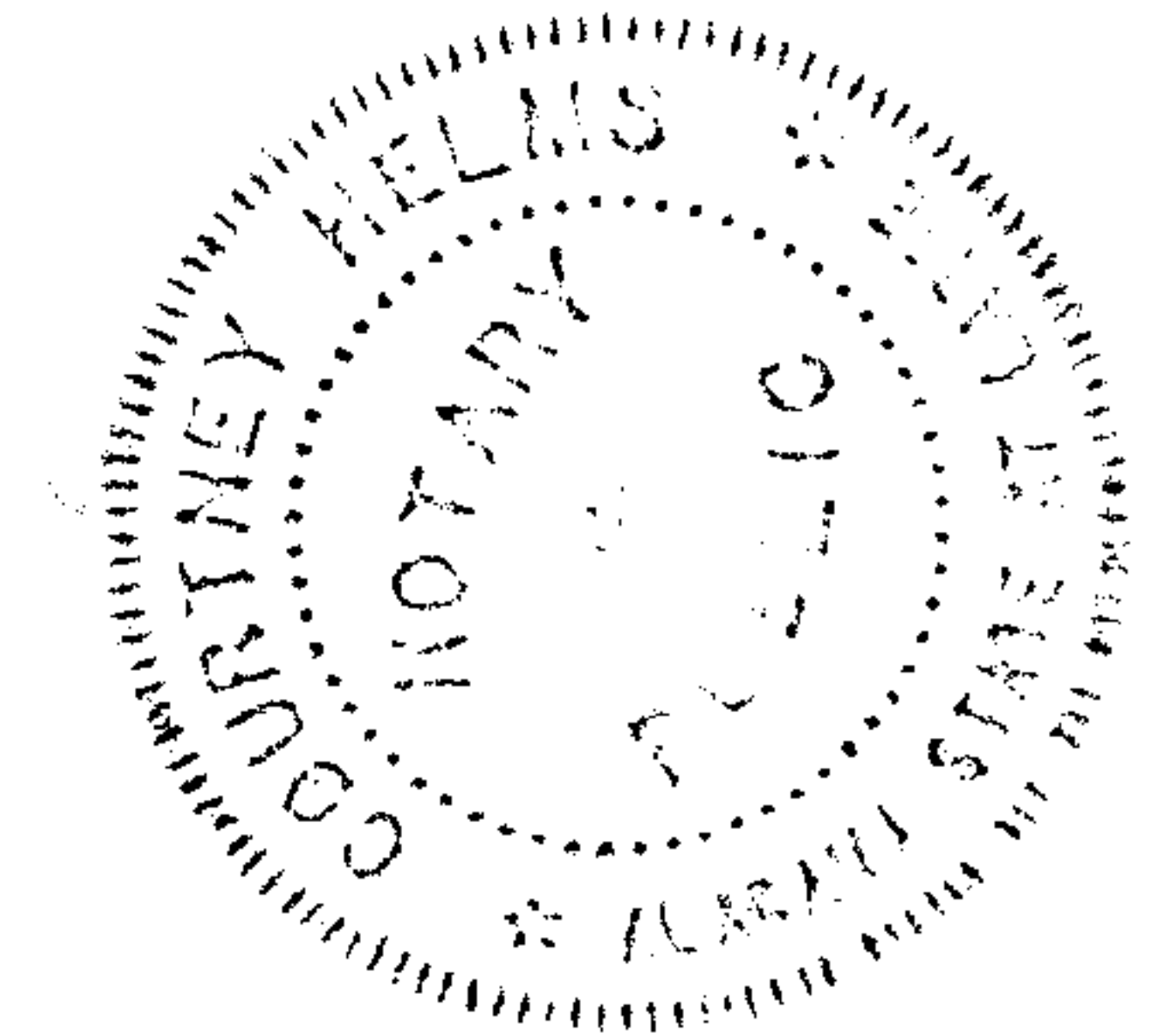
