

SPECIFIC POWER OF ATTORNEY

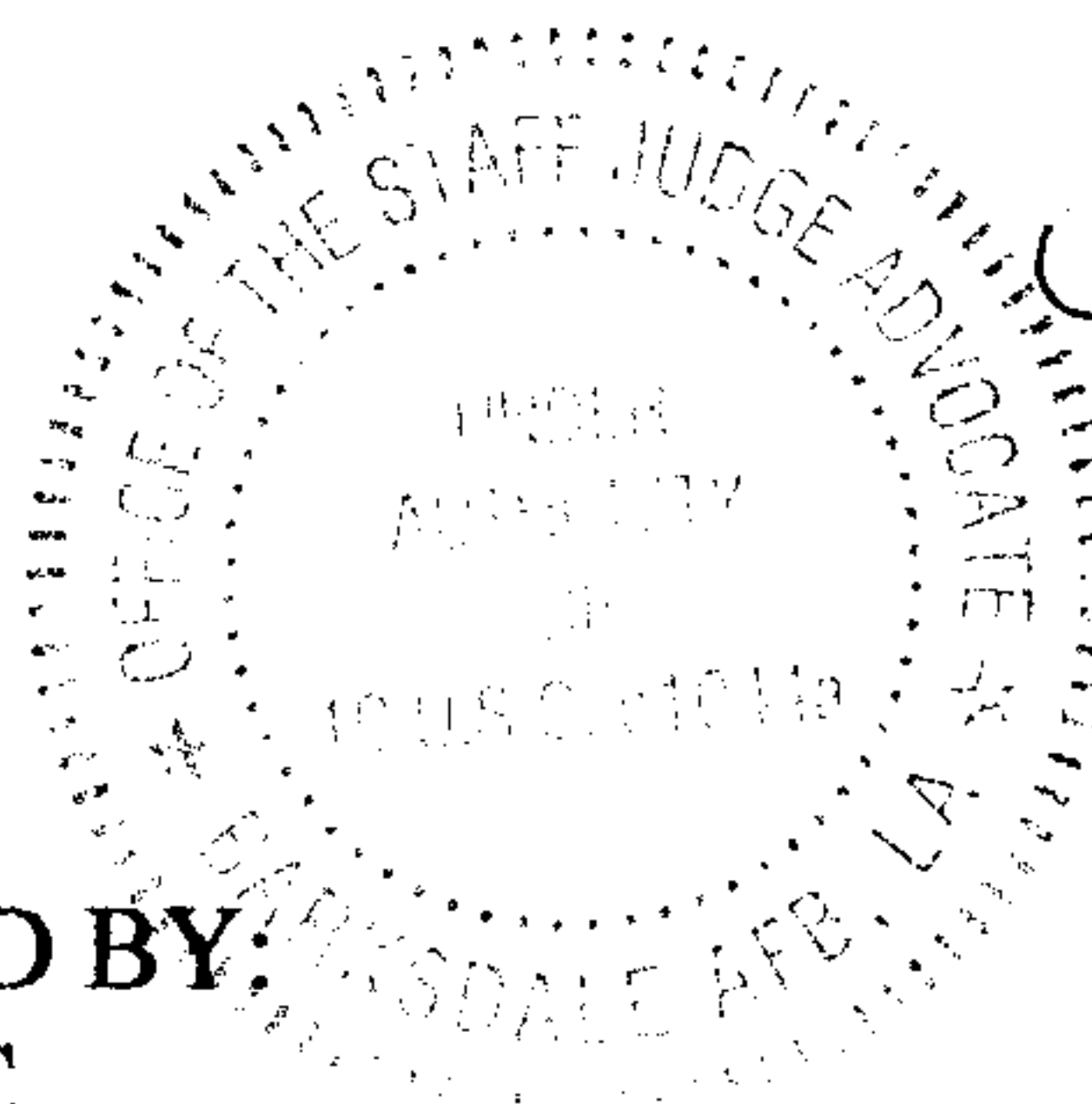


