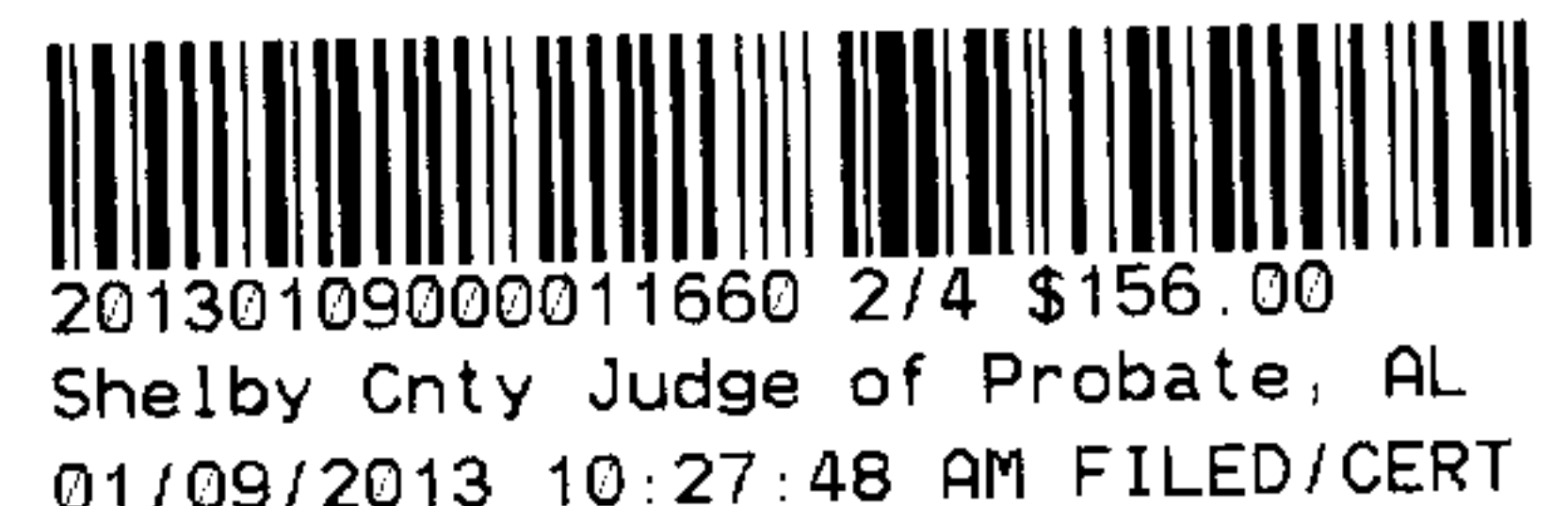

ARTICLE TEN

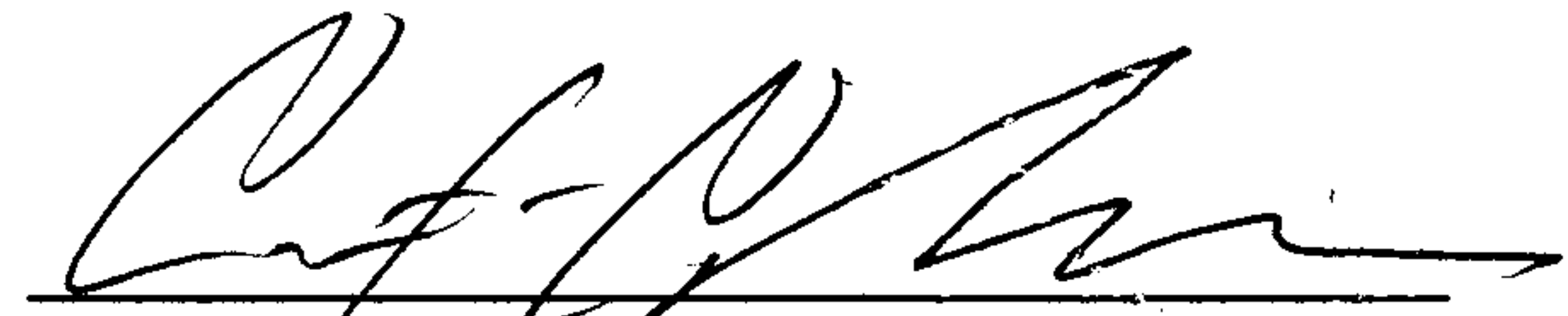
