KNOW ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporator of a corporation under the laws of the State of Alabama, and pursuant to the Alabama Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the corporation shall be Higher Call Heating and Cooling, Inc.

ARTICLE II

PERIOD OF DURATION

The duration of this corporation shall be perpetual.

ARTICLE III

PURPOSE

The purpose for which this corporation is organized is the transaction of any and all lawful business for which a corporation may be organized under the Alabama Business Corporation Act including, but not limited to, providing residential and commercial heating and cooling services, and such other activities as may be incidental to this purpose.

ARTICLE IV

CAPITAL STOCK

The total number of shares that the corporation has authorized to issue is Two Hundred (200). Wesley Criswell has subscribed to Fifty One (51) shares, and Kristy Criswell has subscribed to Forty Nine (49) shares. One Hundred (100) shares shall be reserved by the corporation. It is the intent of

Higher Call Heating and Cooling, Inc. that its stock qualify under Internal Revenue Code Section 1244.

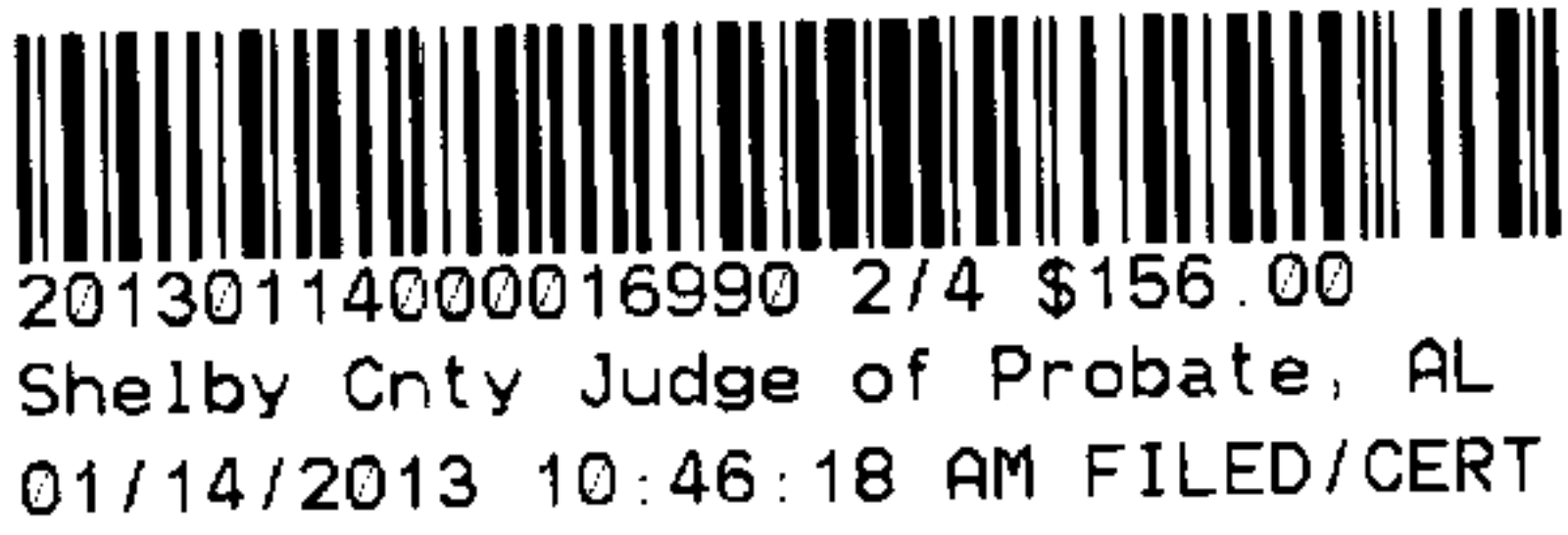




