KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of May, 2007, Brittany M. Gregg, an unmarried person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for MortgageAmerica, Inc., Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument 20070515000225820, said mortgage having subsequently been transferred and assigned to Midfirst Bank, by instrument recorded in Instrument Number 20120420000135370, in the aforesaid Probate Office ("Transferee"); and

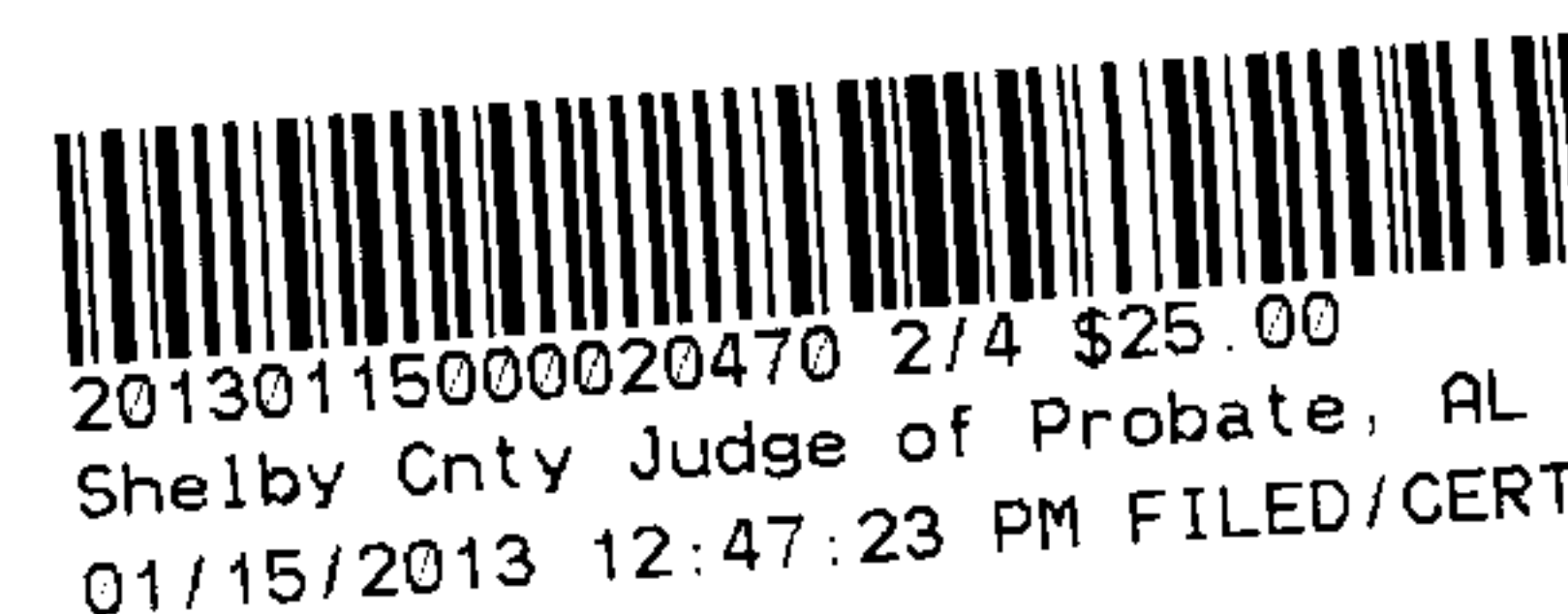

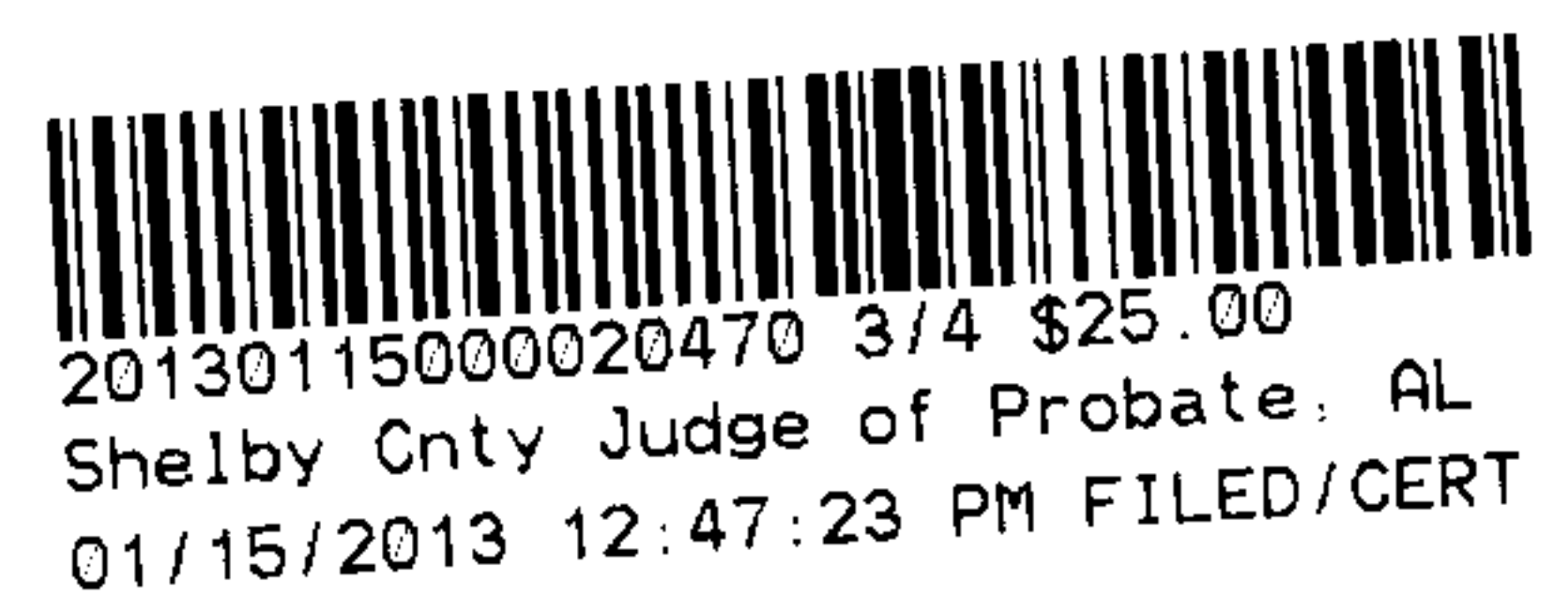
