KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of April, 1999, John Curtis May, Jr. and wife, Sue May, executed that certain mortgage on real property hereinafter described to America's Wholesale Lender, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1999-19623, said mortgage having subsequently been transferred and assigned to Bank of America, N.A., successor by merger to BAC Home Loans Servicing, LP FKA Countrywide Home Loans Servicing LP, by instrument recorded in Instrument Number 20121115000438400, in the aforesaid Probate Office ("Transferee"); and

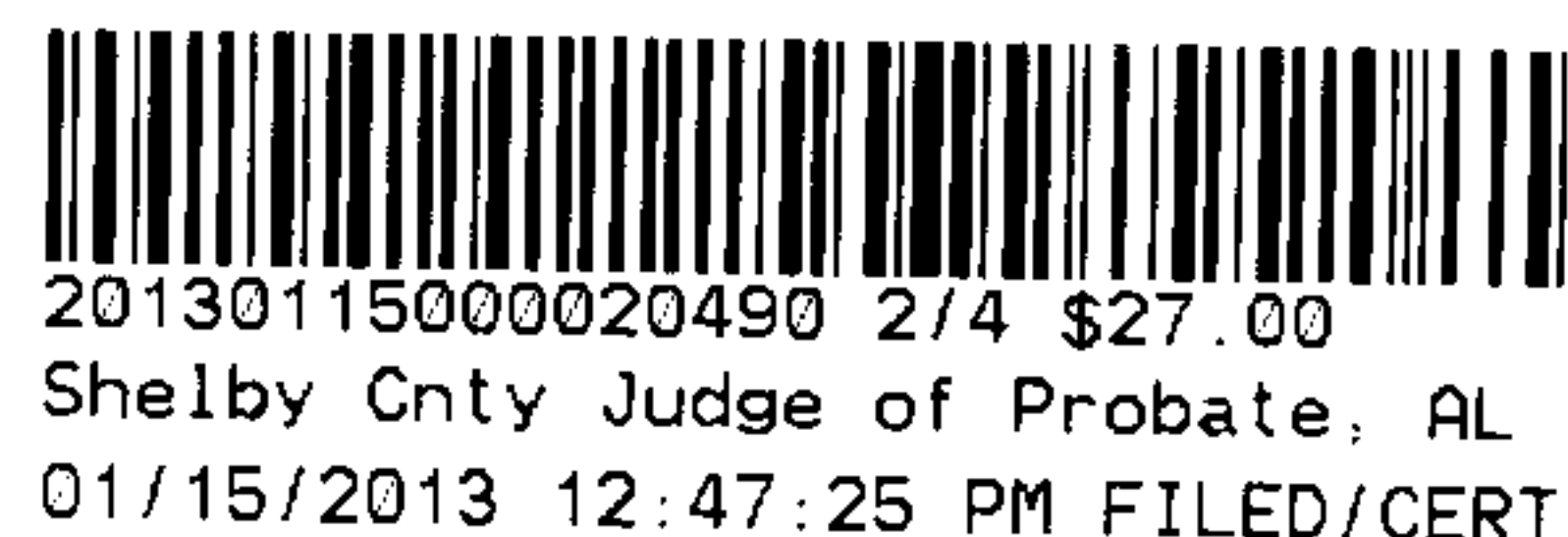
