KNOW ALL MEN BY THESE PRESENTS, That in consideration of THREE HUNDRED SIXTY NINE THOUSAND DOLLARS 00/100 (\$369,000.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **James E. Lambert** and wife, **Deborah M. Lambert**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **Anthony E. Smith and Latoya C. Smith** (herein referred to as Grantees), as joint tenants with right of survivorship, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:



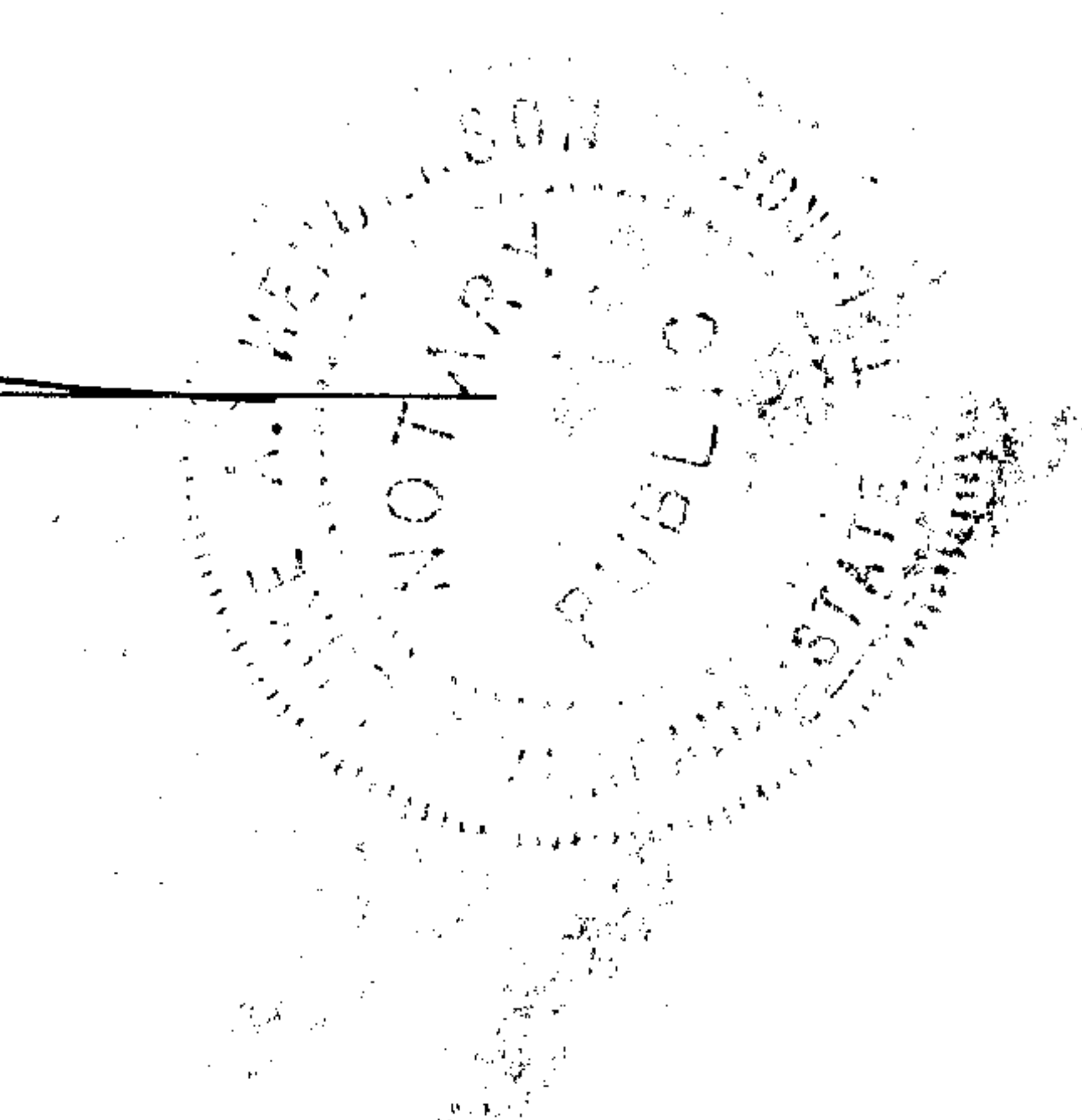

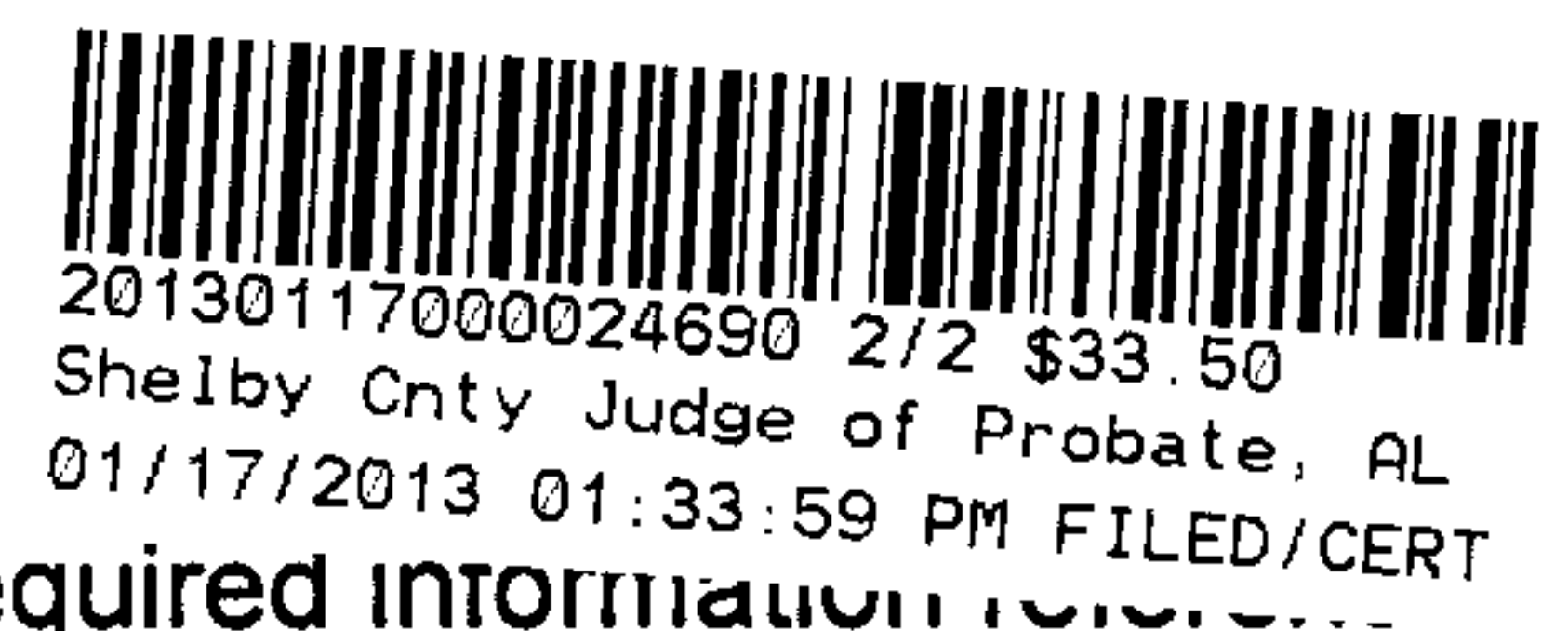
