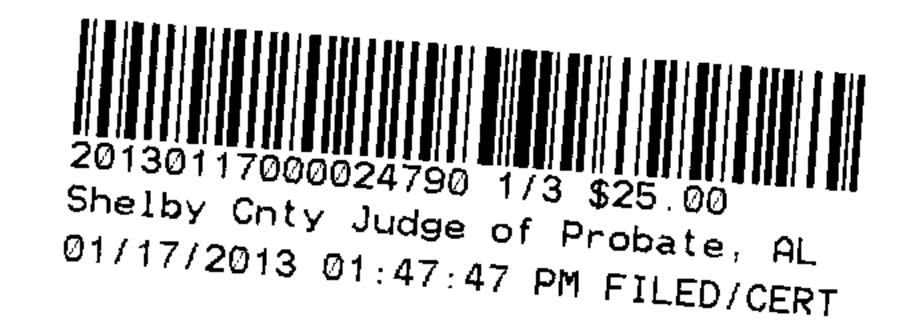

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on November 17, 2005, to-wit: James W. Brown Jr., married man, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for Primary Capital Advisors LC, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on January 4, 2006, in Instrument Number 20060104000004990 and then re-recorded on July 17, 2007 in Instrument Number 20070717000334410, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to The Bank of New York Mellon, formerly known as The Bank of New York, as successor-in-interest to JPMorgan Chase Bank, N.A., as Trustee for Bear Stearns Asset Backed Securities, Bear Stearns ALT-A Trust, Mortgage Pass-Through Certificates, Series 2006-1, by assignment recorded July 19, 2012, and recorded in Instrument Number 20120719000257940, Probate Records of Shelby County, Alabama; and
