ARTICLES OF INCORPORATION

**PURSUANT TO THE PROVISIONS OF THE ALABAMA BUSINESS CORPORATION ACT, THE
UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:**

Article I The name of the corporation:

LockCorp, Inc.

Article II The duration of the corporation is perpetual.

Article III The Corporation has been organized for the following purpose(s):

1. To engage in the business of; to repair, replace, service, construct, build, design, charge, recharge, reconstruct, analyze, test new and used locks; and
2. To purchase, take, receive, lease or otherwise acquire, own, held, improve, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein; and
3. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, limited liability companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof; and
4. To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative, accounting, bookkeeping and other services of every nature, kind and character, which it may legally render; and
5. To act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction; and
6. The transaction of any or all lawful business for which corporations may be incorporated under the Act.

Article IV The number of shares which the corporation shall have the authority to issue is 100

and the par value of each share shall be \$1.00 for a total authorized capital of \$100.00.
