

ARTICLES OF ORGANIZATION OF

Wilson Resha LLC

Pursuant to the Provisions of Sections 10A-5-1.01, *et seq.* of the *Code of Alabama* (1975), the undersigned hereby adopt the following Professional Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is Wilson Resha LLC (the "Company").

ARTICLE II

Duration

The period of duration shall be perpetual or until the Company is dissolved in accordance with the Company's Operating Agreement or in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III

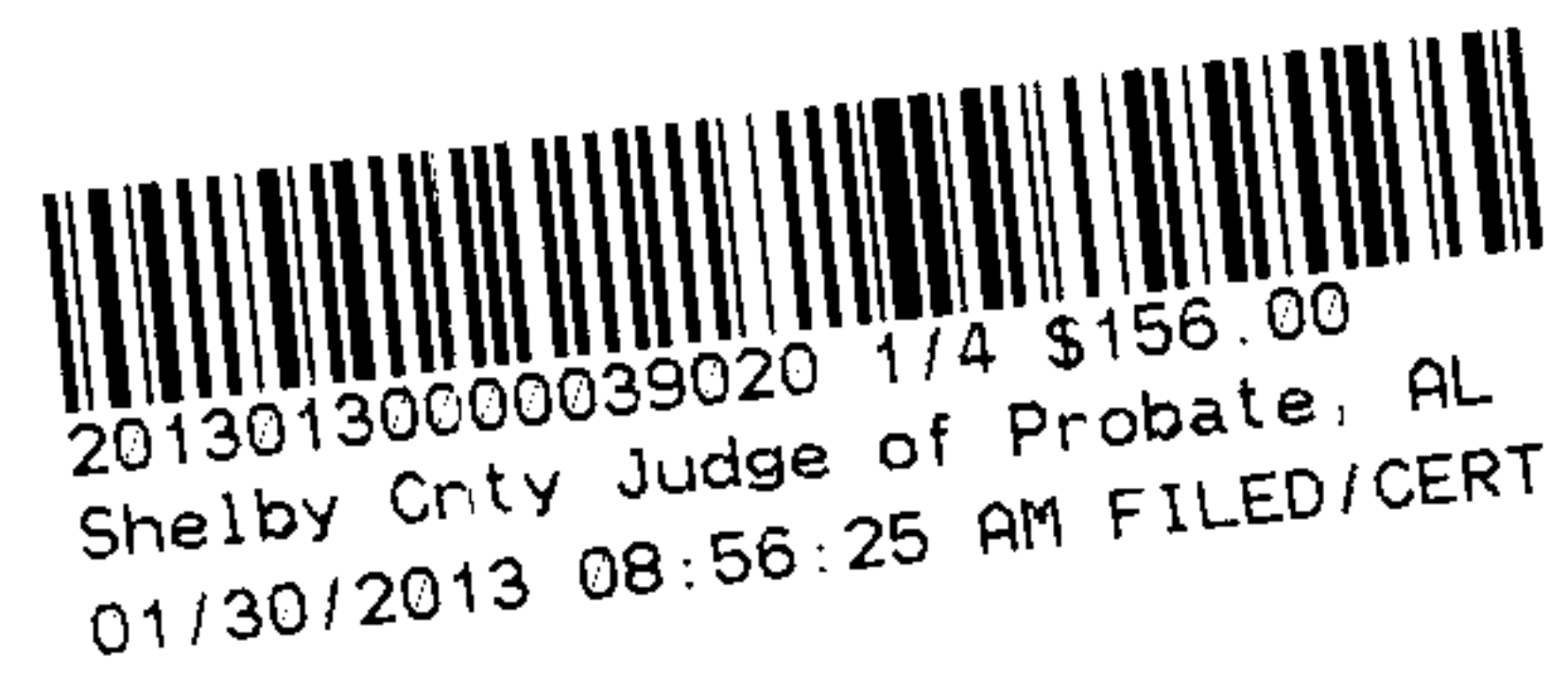
Purposes

ARTICLE VII

Continuation of Business

The Company may be reconstituted and the business of the Company may be continued following an event of dissociation which terminates the membership of a member of the Company if (i) there is at least one remaining member and (ii) the business of the Company is continued by the written consent of all of the remaining members within 90 days after the occurrence of the event of dissociation.

Member Managed

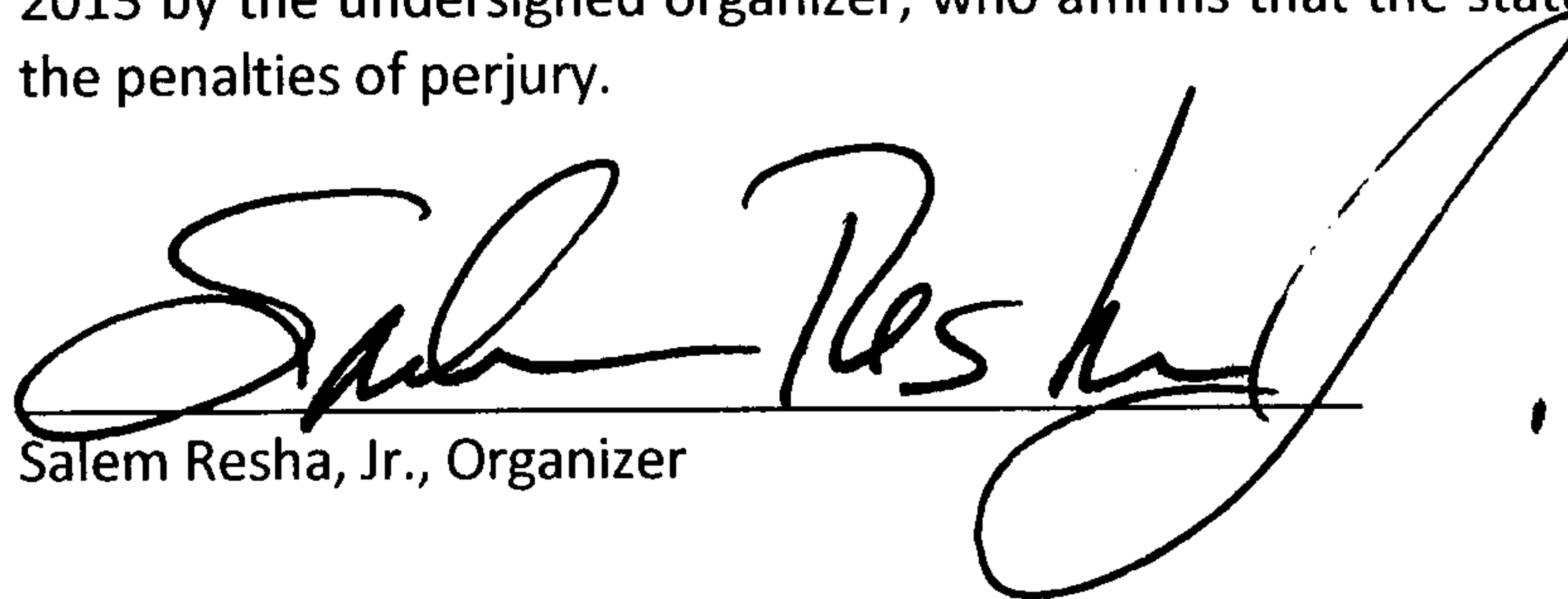
The Company shall be managed by its Members as set forth in the Company's Operating Agreement.
