

**ARTICLES OF ORGANIZATION

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:


1. The name of the Limited Liability Company is Blanton Development, LLC.

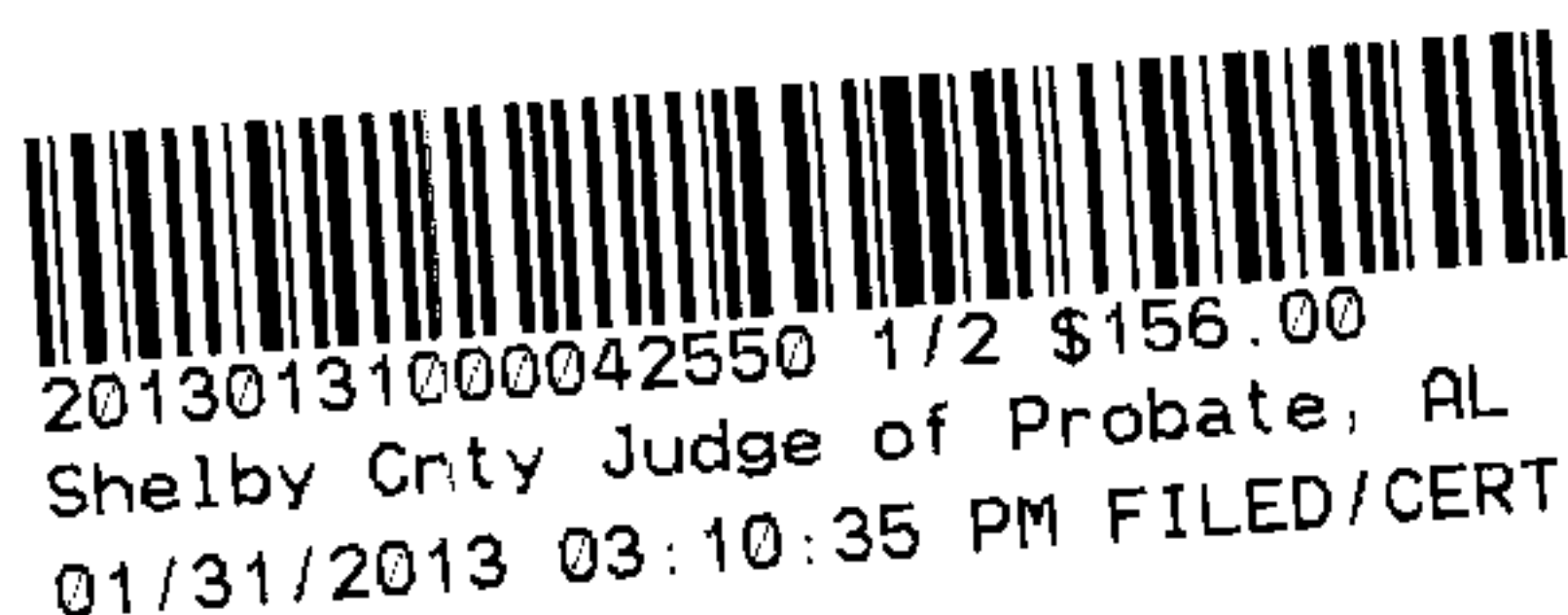
