KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 9th day of March, 2007, Benjamin Crawford and Mary Crawford, husband and wife as joint tenants, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for American Mortgage Express Corp., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number: 20070406000157150, said mortgage having subsequently been transferred and assigned to OneWest Bank FSB, by instrument recorded in Instrument number 20121001000373390, in the aforesaid Probate Office ("Transferee"); and


