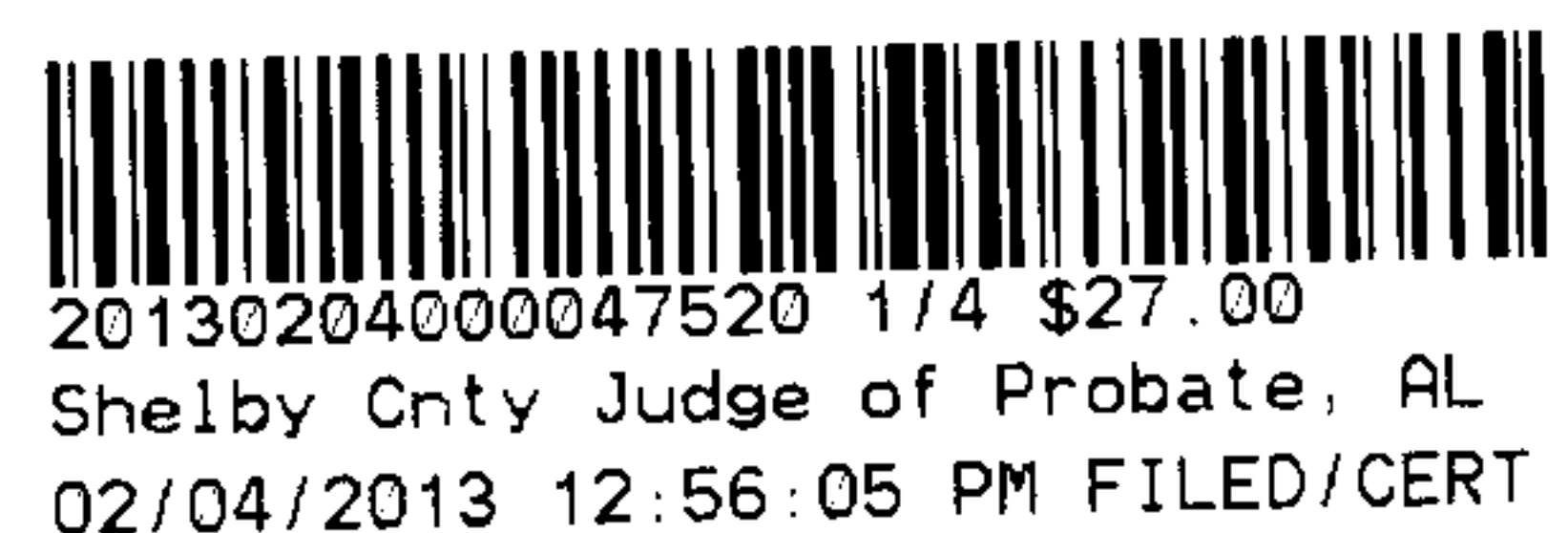
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of March, 2007, Stephen Pruitt and Angelia Pruitt, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Homecomings Financial, LLC (F/K/A Homecomings Financial Network, Inc.), which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070604000259500, said mortgage having subsequently been transferred and assigned to Deutsche Bank Trust Company Americas as Trustee for RALI 2007QS6, by instrument recorded in Instrument Number 20111122000353980, in the aforesaid Probate Office ("Transferee"); and

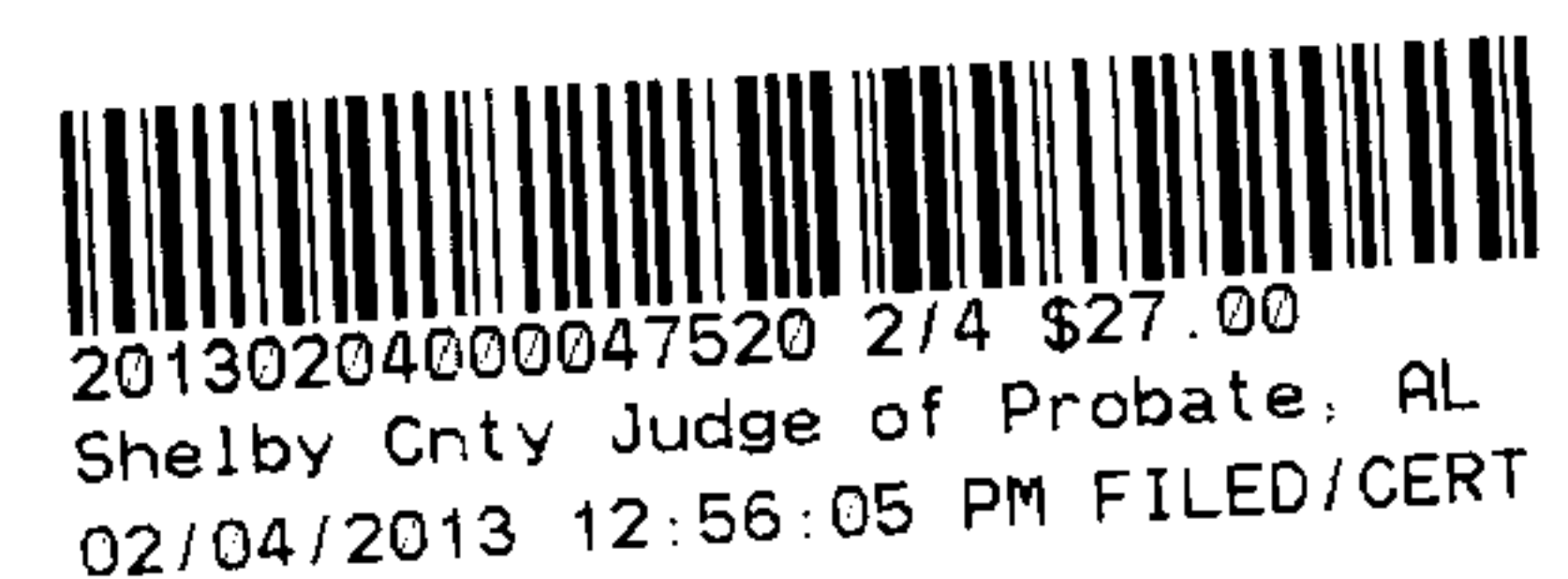
