

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on July 16, 2008, to-wit: Travis Starnes, a single man, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for Renasant Bank, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on July 29, 2008, in Instrument Number 20080729000304730, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which mortgage and the indebtedness secured thereby was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded May 18, 2012, and recorded in Instrument Number 20120518000177120, of said Probate Court records; and

WHEREAS, the said mortgage provides that if said indebtedness or any part thereof should remain unpaid at maturity, then the whole of indebtedness shall at once become due and payable and said mortgage be subject to foreclosure, and further provides that in the event of any such default the Mortgagee shall have the authority to sell said property before the Courthouse door in the City of Columbiana, County of Shelby, State of Alabama, at public outcry for cash after first giving notice by publication once a week for three successive weeks of the time, place and terms of said sale in some newspaper of general circulation published in Shelby County, Alabama, and further provides that in the event of any such sale the person conducting such sale shall have power and authority to execute a deed to the purchaser of said property at such sale, and further provides that the Mortgagee or its assigns may bid and become the purchaser at such sale of the property therein; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and said Mortgagee thereafter gave notice by publication in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on the December 19, 2012, December 26, 2012, and January 2, 2013, that the hereinafter described property would be sold at the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on January 29, 2013, and

WHEREAS, the said sale was held at the time and place stated in said notice, in strict conformity with the powers of sale contained in the said mortgage, at which sale FEDERAL NATIONAL MORTGAGE ASSOCIATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE UNITED STATES OF AMERICA, became the purchaser of the hereinafter described property at and for the sum of \$71,931.30, cash, which was the highest, best, and last bid therefore; and

WHEREAS, the undersigned, James J. Odom, Jr., conducted said sale and acted as auctioneer thereat, under and pursuant to an appointment as such by JPMorgan Chase Bank, National Association;

NOW THEREFORE, IN consideration of the premises Travis Starnes, a single man, and JPMorgan Chase Bank, National Association, both acting by and through the undersigned as their duly constituted and appointed attorney-in-fact and auctioneer at said sale, do hereby grant, bargain, sell and convey unto the said FEDERAL NATIONAL MORTGAGE ASSOCIATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE UNITED STATES OF AMERICA the following described real property situated in Shelby County, Alabama, 3660 Hwy 28, Columbiana, AL 35051, but in the event of a discrepancy, the legal description shall control to-wit:

Beginning at the point of intersection of the West Boundary line of the SE Quarter of the NW Quarter, Section 33, Township 21, Range 1 East, with the South right of way of Shelby County Road No. 28; thence run East along the South right of way line of said road a distance of 350 Feet; thence run South parallel to the West boundary line of SE Quarter of NW Quarter and NE Quarter of SW Quarter, Section 33, Township 21, Range 1 East, a distance of 250 Feet; thence run West Parallel to the South right of way line of said road a distance of 350 Feet to the West boundary line of NE Quarter of SW Quarter; thence run North along the West boundary line of NE Quarter of SW Quarter of NW Quarter, a distance of 250 Feet to the point of beginning.

TO HAVE AND TO HOLD unto the said FEDERAL NATIONAL MORTGAGE ASSOCIATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE UNITED STATES OF AMERICA, its successors and assigns forever, as fully and completely in all respects as the same could or ought to be conveyed to the said FEDERAL NATIONAL MORTGAGE ASSOCIATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE UNITED STATES OF AMERICA under and by virtue of the power and authority contained in the aforesaid

mortgage. Subject, however, to the statutory rights of redemption on the part of those entitled to redeem as provided by the laws of the State of Alabama, also subject to prior liens, ad valorem taxes, easements and restrictions of record.
