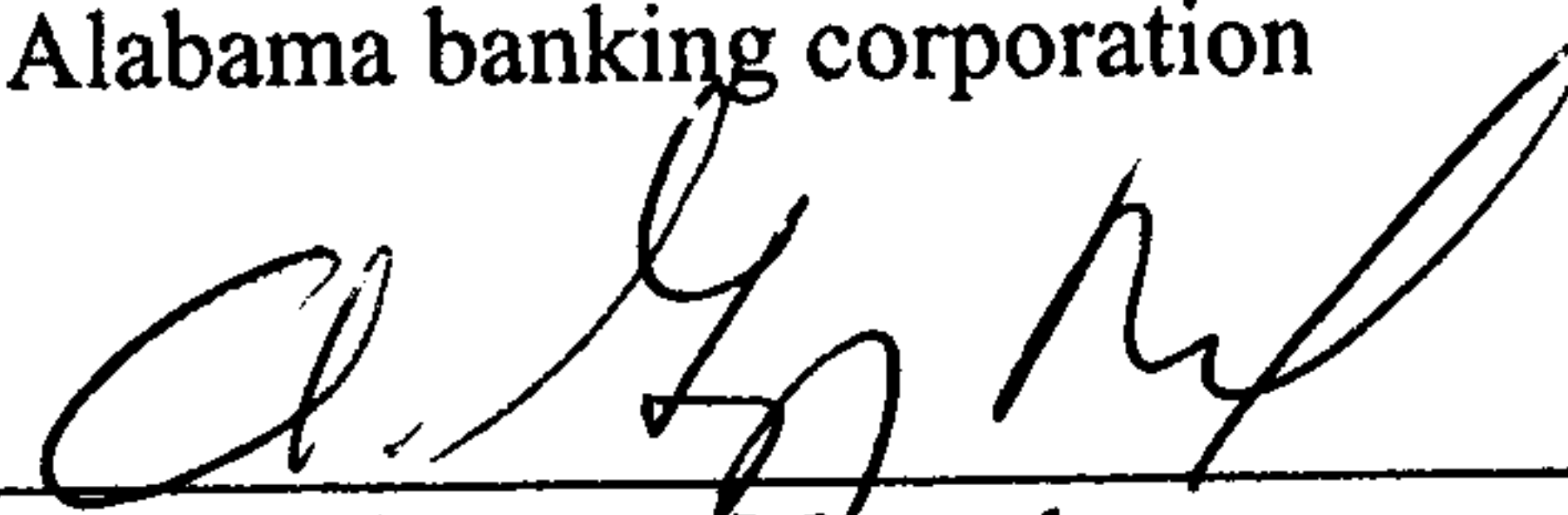
EXHIBIT A
