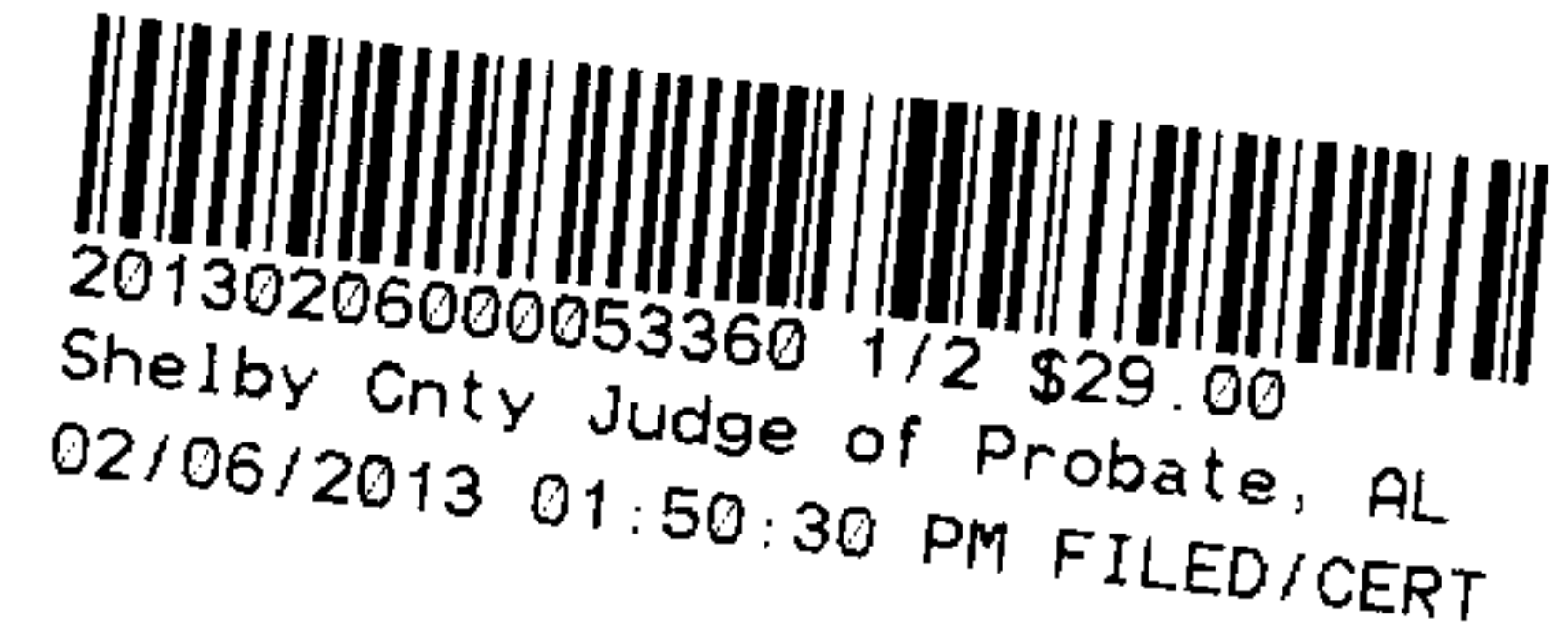

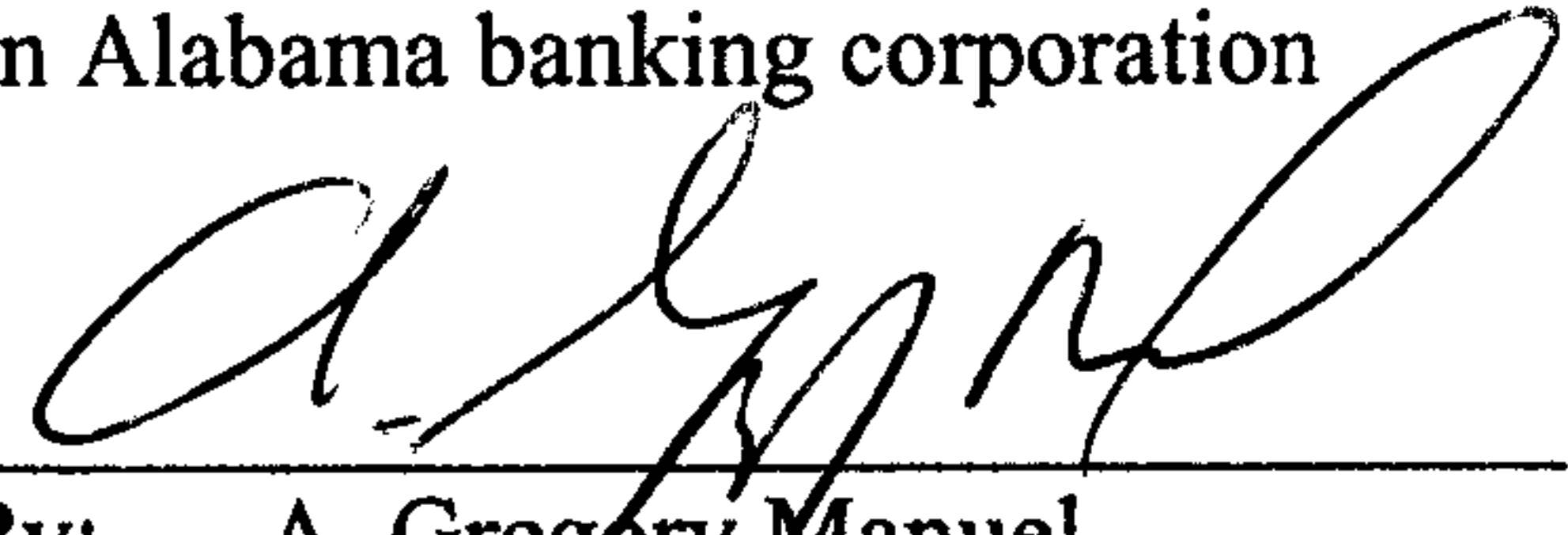
EXHIBIT A
