We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:


1. The name of the Limited Liability Company is Black Belts x4 Unlimited, LLC.

4. The location and mailing address of the initial registered office and the initial registered agent at said address shall be:


