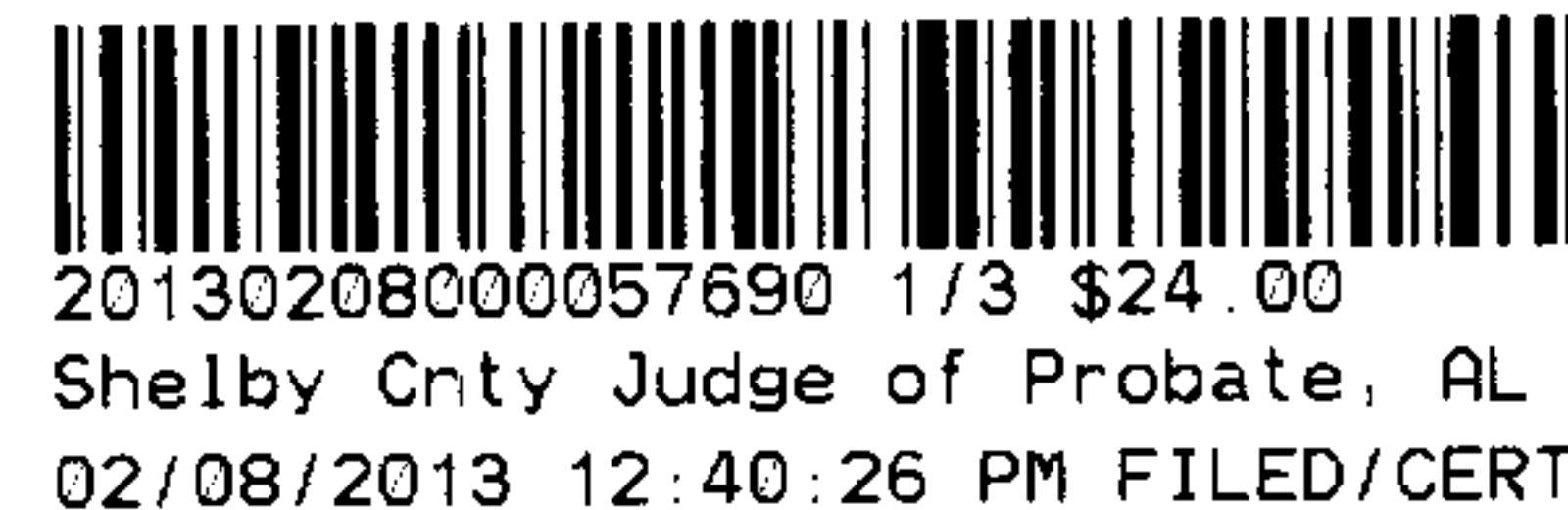

MORTGAGE FORECLOSURE DEED



KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on June 8, 2005, **David Conn and wife, Beverlye C. Conn, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Southeastern Mortgage of Alabama, LLC, its successors and assigns, party of the second part** which said mortgage is recorded in Instrument No. 20050617000302750, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to U.S. Bank National Association as Trustee, successor-in-interest to Wachovia Bank, National Association as Trustee for GSAA Home Equity Trust 2005-14 in Instrument No. 020111011000301630; and

WHEREAS, default in the payment of the indebtedness secured by said mortgage, and U.S. Bank National Association as Trustee, successor-in-interest to Wachovia Bank, National Association as Trustee for GSAA Home Equity Trust 2005-14 did declare all of the indebtedness secured by the said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in the Shelby County Reporter, a newspaper of general circulation in Shelby County, Alabama, in its issues of 10/19, 10/26 & 11/2/11; and

WHEREAS, on November 10, 2011, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of U.S. Bank National Association as Trustee, successor-in-interest to Wachovia Bank, National Association as Trustee for GSAA Home Equity Trust 2005-14 in the amount of **ONE HUNDRED FIFTY-NINE THOUSAND FIVE HUNDRED NINETY-SIX AND 19/100 DOLLARS (\$159,596.19);**, and said property was thereupon sold to U.S. Bank National Association as Trustee, successor-in-interest to Wachovia Bank, National Association as Trustee for GSAA Home Equity Trust 2005-14; and

WHEREAS, Melvin Cowan conducted said sale and acted as auctioneer thereat, under and pursuant to an appointment as such by the Party of the Second Part; and

WHEREAS, said mortgage expressly authorized the mortgagee or auctioneer or any person conducting said sale to execute to the purchaser at said sale a deed to the property so purchased.

NOW, THEREFORE, in consideration of the premises and ONE HUNDRED FIFTY-NINE THOUSAND FIVE HUNDRED NINETY-SIX AND 19/100 DOLLARS (\$159,596.19), on the indebtedness secured by said mortgage, the parties of the First Part and the Party of the Second Part, both acting by and through the undersigned as their duly constituted and appointed attorney-in-fact and auctioneer at said sale, do hereby grant, bargain, sell and convey unto U.S. Bank National Association as Trustee, successor-in-interest to Wachovia Bank, National Association as Trustee for GSAA Home Equity Trust 2005-14, and its successors and assigns, the following described real property, situated in Shelby County, Alabama, to-wit:
