KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on February 26, 2008, **Sydney Annette King, an unmarried woman, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc.; acting solely as nominee for Superior Bank, its successors and assigns, party of the second part** which said mortgage is recorded in Instrument No. 20080303000084440, in the Office of the Judge of Probate of Shelby County, Alabama. Which said Mortgage was last sold, assigned and transferred to Fannie Mae ("Federal National Mortgage Association"), in Instrument No. 20121227000494260; and

WHEREAS, on January 10, 2013, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of Fannie Mae ("Federal National Mortgage Association") in the amount of **TWO HUNDRED TWENTY THOUSAND TWO HUNDRED DOLLARS AND NO CENTS (\$220,200.00)**; and said property was thereupon sold to Fannie Mae ("Federal National Mortgage Association"); and

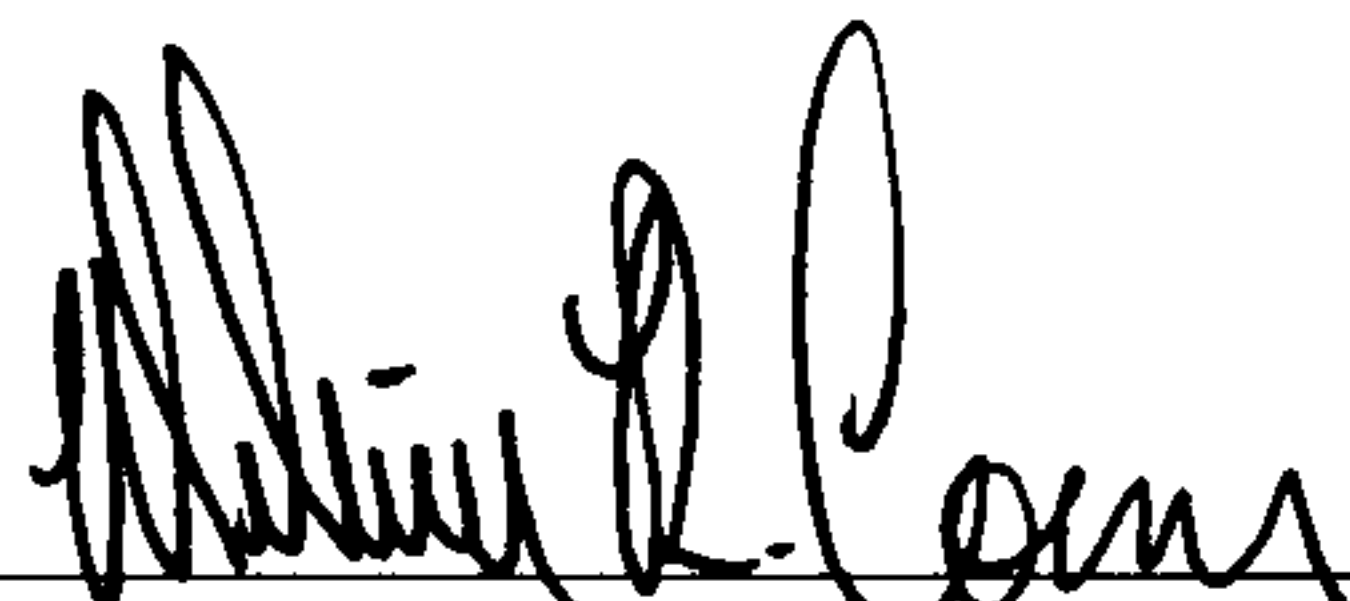

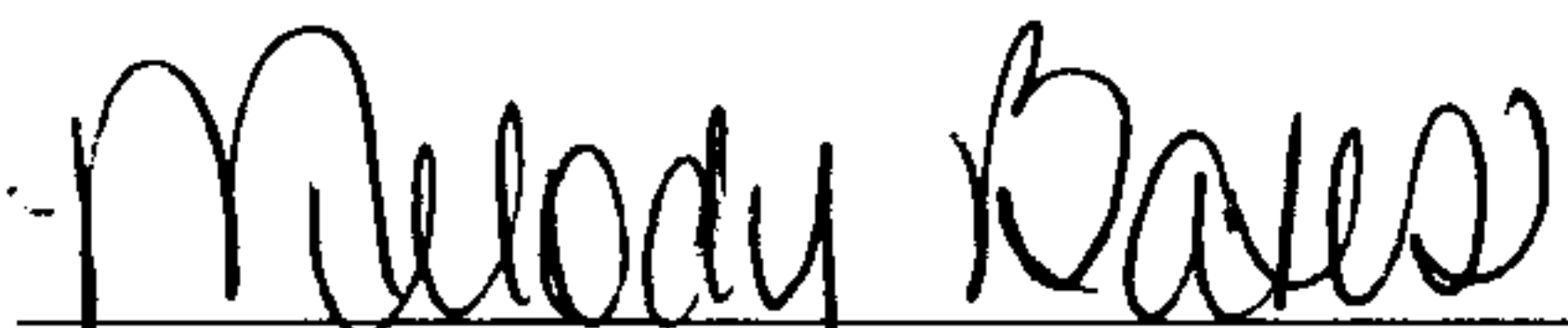

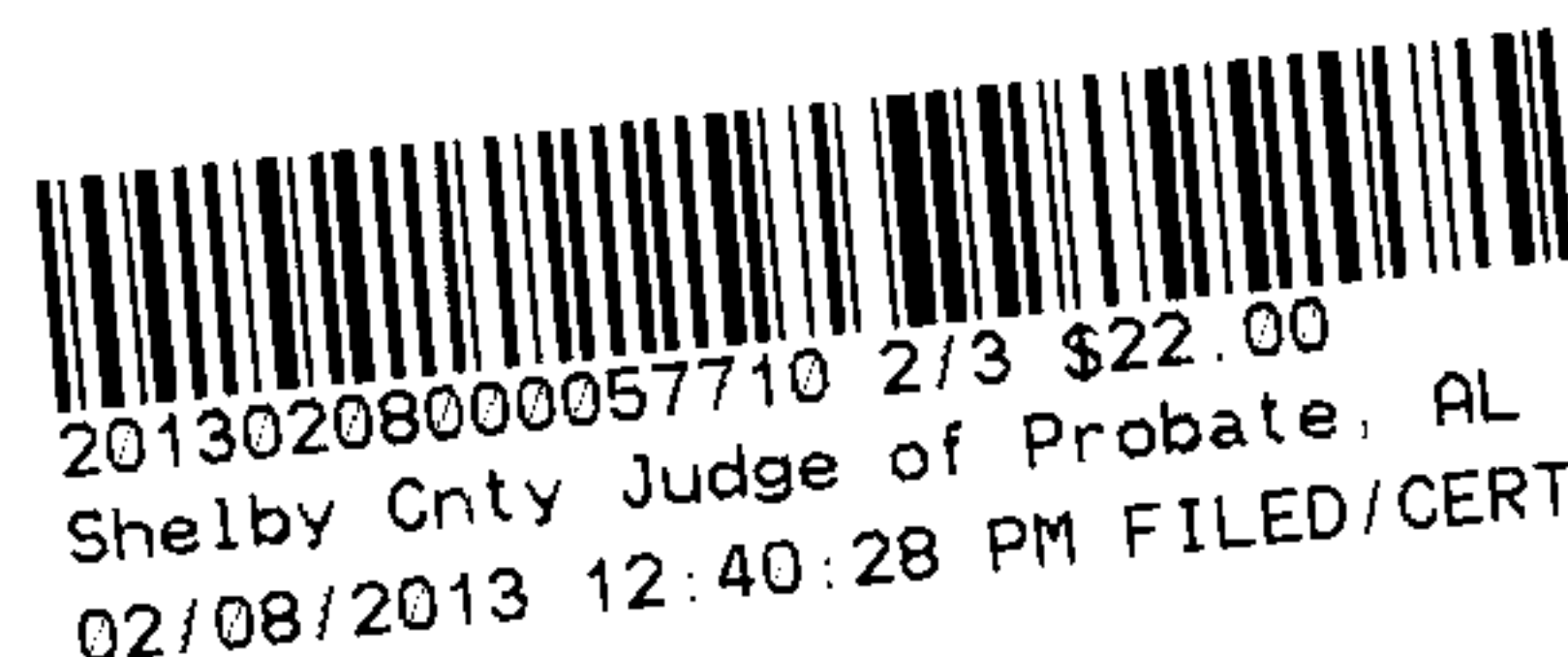
